

Summary | Newport City Council SPF Grants 2025/6

II Cohort September/25

❓ What

The Newport Community Development Grant 2025–2026 funds innovative local projects that strengthen communities and promote inclusion. It supports initiatives in **culture, environment, safety, and equal opportunity**. Grants range from £1,000 to £15,000 (only in very specific cases a slightly higher bit would be accepted) and are available for organisations acting in Newport and delivering impact on the ground. The grant scheme particularly **welcomes innovative and experimental projects that test new concepts** to benefit Newport communities

👥 Who

Voluntary sector organisations, Social enterprises, Registered or unregistered community groups (must have leadership and a bank account), Schools (for extracurricular projects only), SMEs and startups (for non-profit, community-benefiting projects)

Applicants must be based in Newport or clearly demonstrate local impact and ongoing benefit to Newport residents.

Grants are restricted to be used solely for the projects presented in the application process. The projects must meet the outcome criteria and generic evaluation criteria presented below. The funds are intended to support new initiatives, and they cannot be used for projects that have already occurred, nor can funds be sought for ongoing projects or recurrent projects.

Organisations that have already applied on the earlier round are welcomed to apply again with new projects - extensions or refunding of the original project won't be accepted.

Organisations that had an unsuccessful application during the first round are welcomed to submit a new application of a different project.

Opens: 22nd September 2025 | Closes: 13th October 2025

Delivery: October 2025 – January 2026

All applications should be done through the whatimpact.com grant platform. It's an easy 3-step process: 1. Create an organisation profile 2. Describe your project 3. Complete the application form with specific due diligence and budgeting questions.

Evaluation

Applications are scored on the topics below and require a **minimum score** of 17 out of 25, with at least 3 points per category:reach, longevity and legacy, feasibility, value for money and social value (inclusion, wellbeing, environmental impact)

Looking Forward

All funded projects will report on outcomes through the whatimpact.com platform, using clear KPIs, impact tools, and participant feedback mechanisms, showing success stories and lessons learned.

The Newport Community Development Grant Scheme is part of the UK Shared Prosperity Fund (UKSPF), designed to build resilient, healthy and safe neighbourhoods and create innovative approaches to crime prevention through investment in activities that strengthen physical, cultural and social ties and improve access to amenities. The grant is rooted in Newport's vision of "**An Ambitious, Fairer, Greener Newport for Everyone.**"
