**THE HIGHWAYS ENGLAND COMPANY LIMITED
(A590 TRUNK ROAD CROSS-A-MOOR IMPROVEMENT SCHEME)
(SIDE ROADS)
ORDER 2021**

Highways England Company Limited ("Highways England"), a strategic highways company, hereby give notice that it has made, and is about to submit to the Secretary of State for Transport for confirmation, an Order under Sections 14 and 125 of the Highways Act 1980 authorising Highways England to -


- (a) improve highways (including raising, lowering or otherwise altering),
- (b) stop up highways,
- (c) construct new highways,
- (d) stop up private means of access to premises, and
- (e) provide new private means of access to premises

all on, or in the vicinity of, the A590 Trunk Road, which Highways England propose to improve from the junction with Main Road and Cross-a-Moor for a distance of approximately 330 metres.

A copy of the Side Roads Order and of the accompanying plan has been deposited and may be inspected free of charge from 29 April 2021 until 10 June 2021 at Ulverston Library, King's Road, Ulverston, LA12 0BT. The availability of hard copy deposit documents is subject to Ulverston Library remaining open and no further COVID-19 restrictions being put in place. Copies of the same have also been deposited on the Highway England website and can be viewed at <https://highwaysengland.co.uk/our-work/north-west/a590-cross-a-moor/>. Should Ulverston Library close then hard copy documents can be requested by calling David Logan on 07934130575.

Any person may not later than 10 June 2021, object to the confirmation of the Side Roads Order by notice to the Secretary of State for Transport, at the National Transport Casework Team, Tyneside House, Skinnerburn Road, Newcastle Business Park, Newcastle upon Tyne NE4 7AR, or by email to nationalcasework@dft.gov.uk, stating the title of the Side Roads Order and the grounds of their objection. In the preparation of an objection and the statement of grounds of objection it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.

In submitting an objection or representation it should be noted that your personal data and correspondence will be passed to Highways England to enable your objection or representation to be considered. If you do not wish your personal data to be forwarded, please state your reasons when submitting your objection or representation and the Secretary of State will copy your objection or representation, with your name and address removed, to Highways England; if there is to be a Public Local Inquiry they will be seen in that form by the public and the Inspector, who may give them less weight as a result. Highways England may disclose your objection or representation, with your name and address removed, to other parties acting on its behalf.
