NOTICE IS HEREBY GIVEN that Public Local Inquiries will be held into:

- a) the Secretary of State for Transport's proposals for the Orders listed above;
- b) the proposal of the Secretary of State for Communities and Local Government to issue a certificate under Section 19 of the Acquisition of Land Act 1981; and
- c) the objections which have been made in connection with these proposals.

A person nominated by the Planning Inspectorate will hold Public Local Inquiries into the Orders and the proposed notice listed above.

NOTICE IS ALSO GIVEN that in accordance with Rule 5(2) of the Highways (Inquiries Procedure) Rules 1994 and Rule 4(a) of the Compulsory Purchase (Inquiries Procedure) Rules 2007, a local Pre-Inquiries Meeting will be held into the Secretary of State's proposal for the Orders listed above by the person nominated to hold the Public Local Inquiries at a time, date and venue to be advised. All persons with an interest in the Public Local Inquiries are invited to attend.

The Secretary of State for Transport will publish a further notice which will be in accordance with Rule 10 of the Highways (Inquiries Procedure) Rules 1994 in the case of the Orders numbered 3, 4, 5, 6 and 7 and Rule 11 of the Compulsory Purchase (Inquiries Procedure) Rules 2007 in the case of the Orders numbered 1 and 2 above. That notice will also include details of the Orders and the proposed Certificate, which are the subject of the public inquiries, and explain the procedures to be followed for anyone who wishes to appear and to give evidence.

It is requested that any person who intends at the inquiries to submit –

- (a) that any highway or proposed highway to which any of the draft Orders relates should follow an alternative route, or
- (b) that instead of improving, diverting or altering a highway to which the draft Orders relates, a new highway should be constructed on a particular route,

shall send to the A5-M1 Link Scheme Team at the address given below not later than 12th October 2011, sufficient information about the alternative route or the route

of the new highway to enable it to be identified. If you have already submitted such a proposal, then you do not have to submit it again.

Ten Alternative Routes to the proposed scheme were submitted and published on 19 May 2010. Further information on these can be found on the Highways Agency website for the scheme.
