

**THE HIGHWAYS ENGLAND (A27 TRUNK ROAD EAST OF LEWES
IMPROVEMENT SCHEME) (SHARED USE PATH) COMPULSORY
PURCHASE ORDER 2019 ("CPO 2")**

GENERAL VESTING DECLARATION No. 5

THIS GENERAL VESTING DECLARATION is made the 10 day of August 2021

by **HIGHWAYS ENGLAND COMPANY LIMITED** (the "**Authority**")

WHEREAS:

1. On 19 July 2021 an order entitled The Highways England (A27 Trunk Road East of Lewes Improvement Scheme)(Shared Use Path) Compulsory Purchase Order 2021 ("the Order") was confirmed by the Secretary of State for Transport under the powers conferred on him by the Highways Act 1980 and the Acquisition of Land Act 1981 authorising the Authority all interests in the land specified in Schedule 1.
2. Notice of the confirmation of the Order was published in accordance with section 15 of the Acquisition of Land Act 1981 on 6 August 2021.
3. That notice included the statement and form prescribed under section 15(4)(e) and (f) of the Acquisition of Land Act 1981.

NOW THIS DEED WITNESSES that, in exercise of the powers conferred on them by section 4 of the Compulsory Purchase (Vesting Declarations) Act 1981 ("Act"), the Authority hereby declare:-

1. 1. The land described in column 2 of the Schedule hereto (being part of the land authorised to be acquired by the Order) and more particularly coloured pink on the plan annexed hereto, together with the right to enter upon and take possession of the land save for any interests in the land belonging to any Excluded Persons set out in column 3 of the Schedule, shall vest in the Authority as from the end of the period of 3 months from the date on which the service of notices required by section 6 of the 1981 Act is completed ("Vesting Date"). For the purposes of section 2(2) of the 1981 Act, the specified period in relation to the land comprised in this Declaration is one year and one day.


