

Register of Requirements

A303 (Amesbury to Berwick Down) Development Consent Order

On 14 July 2023, the Secretary of State for the Department of Transport (DfT) granted the application for development consent¹ for the A303 Amesbury to Berwick Down (the Scheme).

The A303 (Amesbury to Berwick Down) Development Consent Order 2023 (hereafter 'the DCO'), contains the powers required by National Highways to construct, maintain and operate the Scheme. The DCO includes 'Requirements', which are like planning conditions that specify additional information and details to be provided that will control how the Scheme will be constructed and maintained (implemented). National Highways must implement the Scheme in accordance with these requirements.

In accordance with Requirement 16 of the DCO, National Highways must maintain a 'Register of Requirements' that requires further approvals to be given by the Secretary of State or the Planning Authority.

Discharge of Requirements

- 1. The Requirements can be found in Schedule 2, Part 1 of the DCO. The procedure for discharging the requirements is set out in Schedule 2, Part 2 of the DCO. Through Requirements 4 and 5 National Highways must follow the consultation process and approval process for heritage documents set out in Section 2.1 of the Outline Environmental Management Plan and Section 8.6 of the Detailed Archaeological Mitigation Strategy.
- Requirement discharge applications are submitted to an approving body. For the DCO, the approving body will be either the Department for Transport's National Transport Casework Team who act on behalf of the Secretary of State in determining the discharge of requirements, or the local planning authority, Wiltshire Council.

Navigation of the Register of Requirements

- 3. There are 17 requirements for the DCO. Not all requirements need a discharge application², and some requirements may need more than one discharge application. The requirement register below is split into 6 columns.
 - Req. Ref. This is the requirement number as listed within the DCO, and where relevant, the specific paragraph to which it relates. For example, 4 (5) means Requirement 4, paragraph (5).
 - *Discharge Document to be produced*: This is the name of the discharge document that needs to be produced. There may be

several documents for a single requirement.

- Consent Granting Body: This is the approving body responsible for the discharge of the document noted in the column to the immediate left.
- Date of Submission to Consent Granting Body: This is the date of the final submission to the relevant consent granting body. Where a document has not yet been submitted, this will be blank.
- *Status:* The status of the documents will be listed as either: in preparation, submitted pending approval or approved.
- *Document link*: Once approved, a link will be provided to the approved document. Prior to approval this will be left blank.
- 4. This Register of Requirements is a live document and will be updated as the requirement discharge process progresses. The latest version will always be published here and will be maintained for three years following completion of the project.
- 5. Full details of each requirement can be found within the DCO.
