# **Project Outline**

The Tees Estuary IMMERSE Project is a 4 year project with 1 year left to run and is funded by the EU INTERREG Programme. It aims to address the issue of coastal squeeze on this heavily modified estuary, through the creation of intertidal habitat at a pilot site on the banks of the river. The project will also explore the feasibility of co-locating a mariculture enterprise within the Tees Bay Windfarm. The associated report will look at potentially costs and benefits of such a project and assess what changes will need to take place to see the enterprise thrive

## **Job Description**

The Project Manager role will require you to work closely with project partners, Tees River staff and volunteers to deliver the project outcomes. As part of your responsibilities, you will co-ordinate contractors to implement a programme of capital funded works to create intertidal habitat along the banks of the Tees whilst also completing update reports and submitting claims for the project. You will also be required to complete a feasibility study into the possibility of a mariculture enterprise within the footprint of the Teesside windfarm and lead on a seagrass restoration project within the Tees Estuary.

Proficient in the use of social media, you will help to lead on an innovative approach to build support and capacity for the project, as well as raising awareness about the work of Tees Rivers Trust. Experience of working in estuarine habitats with a wide range of stakeholders is essential as is an ability to build strong working relationships with external partners and understand political sensitivities. You will also be proficient in the use of GIS, in particular Arc GIS Pro, as the job will require you to regularly update the Trust's mapping information.

The role requires common sense, a practical approach and creative problem solving. You will be comfortable working unsupervised and will be expected to evaluate risk sensibly and act accordingly. The post holder will be required to work from home and at outdoor sites throughout the Tees catchment. However, some access to the Trust's offices will be available. The Trust operates a 40 hour working week. The post holder must be prepared to work some evenings and weekends as required. The post holder will occasionally be expected to help with other Trust work as and when required.
