1. Aims

The aims of relationships and sex education (RSE) at our school are to:

- Provide a framework in which sensitive discussions can take place
- Prepare children to have positive and healthy relationships
- Prepare pupils for puberty, and give them an understanding of sexual development and the importance of health and hygiene
- Help pupils develop feelings of self-respect, confidence and empathy
- Create a positive culture around issues of sexuality and relationships
- Teach pupils the correct vocabulary to describe themselves and their bodies

Pupils can develop an awareness of their own personal development and well-being.

2. Statutory requirements

In the **Primary Phase** we must provide relationships education to all pupils as per section 34 of the [Children and Social work act 2017](#).

However, we are not required to provide sex education but we do need to teach the elements of sex education contained in the science curriculum.

In teaching RSE, we must have regard to guidance issued by the secretary of state as outlined in section 403 of the [Education Act 1996](#).

At The Bemrose School we teach RSE as set out in this policy.

In the **Secondary Phase** we must provide RSE to all pupils as per the [Children and Social work act 2017](#).

In teaching RSE, we must have regard to guidance issued by the secretary of state as outlined in section 403 of the [Education Act 1996](#).

3. Definition

RSE is lifelong learning about physical, sexual, moral and emotional development. It is about the understanding of the importance of stable and loving relationships, respect, love and care, for family life. It involves acquiring information, developing skills and forming positive beliefs, values and attitudes. Effective sex and relationship education is essential if young people are to make responsible and well informed decisions about their lives.

RSE is about the emotional, social and cultural development of pupils, and involves learning about relationships, sexual health, sexuality, healthy lifestyles, diversity and personal identity.

RSE involves a combination of sharing information, and exploring issues and values.

RSE is not about the promotion of sexual activity.

4. Curriculum

Our curriculum is set out as per Appendix 1 but it may need to be adapted as and when necessary.

We have developed the curriculum, taking into account the age, needs and feelings of the pupils. If pupils ask questions outside the scope of this policy, teachers will respond in an appropriate manner so they are fully informed and don't seek answers online. Pupil voice is used to inform planning. Our curriculum has been developed to ensure contextual information relevant to our setting are embedded. Key themes include:

- Sexual harassment
- Online safety and bullying
- Sexual consent
- Pregnancy
- Gender stereotypes

Primary sex education will focus on:

- Preparing boys and girls for the changes that adolescence brings
- How a baby is conceived and born

5. Delivery of RSE

In the Primary Phase, RSE is taught by the class teacher and delivered through the PSHE, Science, Citizenship and circle time lessons. In the Secondary Phase, RSE is taught within the PSHE curriculum. Biological aspects of RSE are also taught within the science and Form Time curriculum, other aspects are included in religious education (RE). Pupil voice is gathered throughout each academic year and this informs/shapes the curriculum direction to meet the local needs.

For Secondary pupils, stand-alone sex education sessions may be delivered by the school nurse.

Primary Phase

Relationships education focuses on teaching the fundamental building blocks and characteristics of positive relationships including:

- Families and people who care for me
- Caring friendships
- Respectful relationships
- Online relationships
- Being safe

Secondary Phase

RSE focuses on giving young people the information they need to help them develop healthy, nurturing relationships of all kinds including:

- Families
- Respectful relationships, including friendships
- Online and media
- Being safe
- Intimate, and sexual relationships, including sexual health
- Safe behaviour in relationships

Post-16

Delivered by a designated Citizenship teacher Year 12 and Year 13, RSE content is covered through the following focus in lessons:

- Control in relationships
- Contraception
- STIs
- Child Sexual Exploitation
- LGBTQ+ rights

These areas of learning are taught within the context of family life taking care to ensure that there is no stigmatisation of children based on their home circumstances (families can include single parent families, LGBTQ+ parents, families headed by grandparents, adoptive parents, foster parents/carers amongst other structures) along with reflecting sensitively that some children may have a different structure of support around them (for example: looked after children or young carers)

6. Roles and responsibilities

6.1 The Governing Board

The Governing Board will approve the RSE policy, and hold the Executive Headteacher to account for its implementation.

6.2 The Executive Headteacher

The Executive Headteacher is responsible for ensuring that RSE is taught consistently across the school, and for managing requests to withdraw pupils from non-statutory components of RSE (see section 7).

6.3 Staff

All staff are responsible for:

- Delivering RSE in a sensitive way
- Modelling positive attitudes to RSE
- Monitoring progress in RSE and addressing concerns
- Responding to the needs of individual pupils
- Responding appropriately to pupils whose parents wish them to be withdrawn from the non-statutory components of RSE

Staff do not have the right to opt out of teaching RSE. Staff who have concerns about teaching RSE are encouraged to discuss this with the Executive Headteacher.

Primary classroom teachers are responsible for the delivery of the PSHE programme in EYFS, KS1 and KS2.

Humanities teachers and those with PSHE on their timetable are responsible for the delivery of KS3, KS4 and KS5 provision. Form tutors will explore elements of RSE with the pupils in their form. Learning walks take place to monitor delivery.

6.4 Pupils

Pupils are expected to engage fully in RSE and, when discussing issues related to RSE, treat others with respect and sensitivity.

7. Parents' right to withdraw

Primary Phase

Parents do not have the right to withdraw their children from relationships education

Secondary Phase

Parents have the right to withdraw their children from the non-statutory components of sex education within RSE up to and until 3 terms before the child turns 16. After this point, if the child wishes to receive sex education rather than being withdrawn, the school will arrange this.

Requests for withdrawal should be put in writing using the form found in Appendix 3 of this policy and addressed to the Executive Headteacher. This must specify the specific content area of the RSE curriculum for which the request is being forwarded.

A copy of withdrawal requests will be placed in the pupil's educational record. The Executive Headteacher will discuss the request with parents and take appropriate action.

Alternative work will be given to pupils who are withdrawn from sex education.

A request which results in a withdrawal will have the duration of one academic year, in which time pupils will be covering different age-appropriate RSE content. A new request form must be submitted for each academic year.

As of April 2021 there have been no parental withdrawal requests.

8. Training

The Humanities team will deliver and are familiarised with the RSE programme of study. Form tutors are trained on the pastoral nature of their role.

The Deputy Headteacher: Inclusion, or the lead teacher for PSHE may invite professionals from outside the school, such as school nurses or sexual health professionals, to provide support and training to staff teaching RSE.

The school will regularly audit and reflect on the needs of our pupils and address this with adaptations to training and the curriculum for staff that will impact positively on our children.

9. Monitoring arrangements

The delivery of RSE is monitored by the Head of the Primary Phase and the Deputy Headteacher – Inclusion, through:

- Line management meetings with lead teachers, with responsibility for PSHE in both phases (see minutes with Executive Headteacher)
- Reviews of schemes of work and lesson observations.
- Pupils' development in RSE is monitored by class teachers as part of the internal assessment system including learning walks and the internal faculty review process.

This policy will be reviewed by the Executive Headteacher. At every review, the policy will be approved by the Governing Board.

This will correspond with the safeguarding audit.

Governors will monitor the implementation of this policy through dialogue with staff, pupil voice, meetings with key leaders and their visits or interactions with the school.

10. Covid-19 Interventions

Ensuring a consistent and thorough delivery for learners, elements of the Year 6 programme were absorbed into KS3 lessons such as content on 'puberty and body changes' in adolescence. This was incorporated into our phase transition. These omissions in learning for 2020/21 were recognised and acted on. Key transition points and gaps were captured and acted upon. This evaluation and reflection is ongoing.

As a response to the absences from learning due to Covid-19, a recovery programme was adopted to ensure the RSE provision that was missed at KS2 was rescheduled in KS3 and likewise in KS4 and 5.

Online and media	<p>Their rights, responsibilities and opportunities online, including that the same expectations of behaviour apply in all contexts, including online</p> <p>About online risks, including that any material someone provides to another has the potential to be shared online and the difficulty of removing potentially compromising material placed online</p> <p>Not to provide material to others that they would not want shared further and not to share personal material which is sent to them</p> <p>What to do and where to get support to report material or manage issues online</p> <p>The impact of viewing harmful content</p> <p>That specifically sexually explicit material e.g. pornography presents a distorted picture of sexual behaviours, can damage the way people see themselves in relation to others and negatively affect how they behave towards sexual partners</p> <p>That sharing and viewing indecent images of children (including those created by children) is a criminal offence which carries severe penalties including jail</p> <p>How information and data is generated, collected, shared and used online</p>
