- 6 The company is close within the meaning of the Income and Corporation Taxes Act 1988, as amended


### **Statement of directors' responsibilities**


For the year ended 30 April 2012 the company was entitled to exemption from audit under section 480 for the Companies Act 2006 relating to dormant companies
