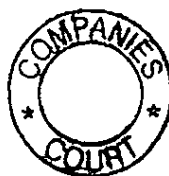

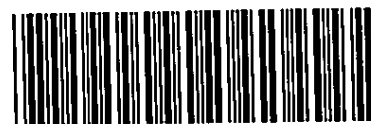
AND UPON the solicitors for the Claimant and for the Registrar of Companies (the Defendant) both consenting to this Order

- (5) the hearing fixed for the 22 October 2010 at 2 00 pm be vacated
