Pursuant to Chapter 2 of Part 13 of the Companies Act 2006 (the "Act"), the directors of the Company propose that the following resolution be passed as special resolutions (the "Resolutions")

SPECIAL RESOLUTIONS

- 1 **THAT**, pursuant to section 641(1)(a) of the Act, the entire amount standing to the credit of the share premium account of the Company as at the date on which this Resolution is passed, being in the sum of £2,625,063, be cancelled and extinguished
- 2 **THAT**, pursuant to section 641(1)(a) of the Act, the share capital of the Company be reduced from £19,293,777 to £2 00 by reducing the nominal value of each of the Company's 19,293,777 issued ordinary shares of £1 00 each to £0 000000104 each
- 3 **THAT** the amount arising upon the reduction pursuant to Resolutions 1 and 2 above, being in the aggregate sum of £21,918,838 be credited to the profit and loss account of the Company "
