- have been prepared in accordance with the requirements of the Companies Act 2006.





There are no syndicate transactions required to be reported in the general business technical account for the year ended 31 December 2014 and there are no assets or liabilities arising as a result of the underwriting activities that are required to be reported in the Balance Sheet at 31 December 2014

Basis of Currency Translation

Assets and liabilities are translated into Sterling at the rates of exchange at the Balance Sheet date

Deferred Taxation

Deferred tax is provided in full on timing differences which result in an obligation at the Balance Sheet date to pay more tax, or a right to pay less tax, at a future date, at rates expected to apply when they crystallise based on current tax rates and law

Deferred tax assets are recognised to the extent that it is regarded as more likely than not that they will be recovered

These monies can only be released from the provision of this Deed with Lloyd's express permission and only in circumstances where the amounts are either replaced by an equivalent asset, or after the expiration of the Company's liabilities in respect of its underwriting.
