THIS DEED is dated 18 December 2018

**BETWEEN**

- (1) **SENNYBRIDGE (HAYLE HARBOUR AUTHORITY) LIMITED**, a private company limited by shares, registered in England and Wales (registered number 09568754) The Old Customs House, North Quay, Hayle, TR27 4BL (the "**Chargor**"); and
- (2) **RS LENDER III, S.A R.L.** a private limited liability company (*société à responsabilité limitée*) incorporated under the laws of Luxembourg, having its registered office at 4 Rue Lou Hemmer, L-1748 Luxembourg – Findel, Grand-Duchy of Luxembourg and registered with the Luxembourg Trade and Companies Register (*Registre de Commerce et des Sociétés, Luxembourg*) (as the "**Secured Creditor**").

**BACKGROUND**

- (A) The Chargor enters into this Deed in connection with the Facility Agreement (as defined below).
- (B) It is intended that this document takes effect as a deed notwithstanding the fact that a party may only execute this document under hand.

**IT IS AGREED** as follows:

**1. DEFINITIONS AND INTERPRETATION**

**1.1 Definitions**

In this Deed:

"**Act**" means the Law of Property Act 1925.

"**Facility Agreement**" means the GBP25,000,000 facility agreement dated on or about the date of this Deed between (among others) the Chargor and the Secured Creditor.

"**Investments**" means all shares, stocks, debentures, bonds or other securities or investments owned by the Chargor or held by any nominee or trustee on its behalf.

"**Mortgaged Property**" means all freehold or leasehold property included in the definition of Security Asset.

"**Party**" means a party to this Deed.

"**Receiver**" means a receiver or receiver and manager or administrative receiver, in each case appointed under this Deed.

"**Relevant Contract**" means:

- (a) any Occupational Lease, any Agreement for Lease and any other lease, licence or other agreement giving a right to occupation of the Property (or any part

thereof), whether as superior landlord, landlord, tenant, sub-tenant or licensee;  
and

- (b) any Development Document.

**"Secured Liabilities"** means all present and future obligations and liabilities (whether actual or contingent and whether owed jointly or severally or in any other capacity whatsoever) of the Chargor to any Secured Party under each Finance Document.

**"Security Period"** means the period beginning on the date of this Deed and ending on the date on which all the Secured Liabilities have been unconditionally and irrevocably paid and discharged in full and the Secured Assets have been released from the Security pursuant to Clause 20 (*Release*).

## 1.2 Construction

- (a) Capitalised terms defined in the Facility Agreement have the same meaning in this Deed unless expressly defined in this Deed.
- (b) The provisions of Clause 1.2 (*Construction*) of the Facility Agreement apply to this Deed as though they were set out in full in this Deed except that references to the Facility Agreement will be construed as references to this Deed.
- (c) Unless a contrary indication appears, a reference in this Deed to:
  - (i) a **"Finance Document"** or any other agreement or instrument is a reference to that Finance Document or Finance Document or other agreement or instrument as amended, novated, supplemented, extended or restated;
  - (ii) any **"rights"** in respect of an asset includes:
    - (A) all amounts and proceeds paid or payable;
    - (B) all rights to make any demand or claim; and
    - (C) all powers, remedies, causes of action, security, guarantees and indemnities,in each case in respect of or derived from that asset;
  - (iii) any **"share"**, **"stock"**, **"debenture"**, **"bond"** or **"other security"** or **"investment"** includes:
    - (A) any dividend, interest or other distribution paid or payable;
    - (B) any right, money or property accruing or offered at any time by way of redemption, substitution, exchange, bonus or preference, under option rights or otherwise,



in each case in respect of that share, stock, debenture, bond or other security or investment; and

- (iv) the term **this Security** means any Security created by this Deed.
- (d) Any covenant of the Chargor under this Deed (other than a payment obligation which has been discharged) remains in force during the Security Period.
- (e) The terms of the other Finance Documents and of any other agreement or instrument between any Parties in relation to any Finance Document are incorporated in this Deed to the extent required to ensure that any purported disposition, or any agreement for the disposition, of any freehold or leasehold property contained in this Deed is a valid disposition in accordance with section 2(1) of the Law of Property (Miscellaneous Provisions) Act 1989.
- (f) If the Secured Creditor considers that an amount paid to a Secured Party under a Finance Document is capable of being avoided or otherwise set aside on the liquidation or administration of the payer or otherwise, then that amount will not be considered to have been irrevocably paid for the purposes of this Deed.
- (g) Unless the context otherwise requires, a reference to a Security Asset includes the proceeds of any disposal of that Security Asset.

### 1.3 **Third party rights**

- (a) Unless expressly provided to the contrary in a Finance Document, a person who is not a Party has no right under the Third Parties Act to enforce or to enjoy the benefit of any term of this Deed.
- (b) Notwithstanding any term of any Finance Document, the consent of any person who is not a Party is not required to rescind or vary this Deed at any time.
- (c) Any Receiver may enforce and enjoy the benefit of any Clause which expressly confers rights on it, subject to paragraph (b) above and the provisions of the Third Parties Act.

### 1.4 **Facility Agreement**

- (a) This Deed is subject to the Facility Agreement.
- (b) In the event of any inconsistency between the terms of this Deed and the terms of the Facility Agreement, the terms of the Facility Agreement shall prevail.

## 2. **COVENANT TO PAY AND TO PERFORM**

The Chargor covenants with and undertakes to the Secured Creditor that it will:

- (a) duly, unconditionally and punctually pay and discharge all monies and liabilities whatsoever which now are or at any time hereafter may (whether before or after demand) become due, owing or incurred by the Chargor to each of the Secured

Parties, whether actually or contingently, under this Deed or any other of the Finance Documents to which the Chargor is a party; and

- (b) observe, perform and satisfy all its other obligations and liabilities under this Deed or any other of the Finance Documents.

### 3. CREATION OF SECURITY

#### 3.1 General

- (a) The Chargor must pay or discharge the Secured Liabilities in the manner provided for in the Finance Documents.
- (b) All the security created under this Deed:
  - (i) is created in favour of the Secured Creditor;
  - (ii) is created over present and future assets of the Chargor;
  - (iii) is security for the payment of all the Secured Liabilities; and
  - (iv) is made with full title guarantee in accordance with the Law of Property (Miscellaneous Provisions) Act 1994.

#### 3.2 Land

- (a) The Chargor charges:
  - (i) by way of a first legal mortgage all estates or interests in any freehold or leasehold property now owned by it; this includes the real property (if any) specified in Schedule 1 (*Property*); and
  - (ii) (to the extent that they are not the subject of a mortgage under paragraph (i) above) by way of a first fixed charge all estates or interests in any freehold or leasehold property now or subsequently owned by it.
- (b) A reference in this Clause 3 to a mortgage or charge of any freehold or leasehold property includes:
  - (i) all buildings, fixtures, fittings and fixed plant and machinery on that property; and
  - (ii) the benefit of any covenants for title given or entered into by any predecessor in title of the Chargor in respect of that property or any moneys paid or payable in respect of those covenants.

#### 3.3 Investments

The Chargor charges by way of a first fixed charge its interest in all its Investments, including, in each case, the right to income, distributions and the proceeds of any of the

foregoing, together, in each case, with all rights in respect thereof and all dividends, interest, cash or other distributions, accretions or Investments in respect of or deriving from the foregoing.

#### 3.4 **Plant and machinery**

To the extent that they are not the subject of a mortgage or a first fixed charge under Clause 3.2 (*Land*), the Chargor charges by way of a first fixed charge all plant and machinery owned by the Chargor and its interest in any plant or machinery in its possession.

#### 3.5 **Credit balances**

- (a) The Chargor charges by way of a first fixed charge all of its rights in respect of each of its bank accounts, any amount standing to the credit of such account and the debt represented by it.
- (b) The Chargor charges by way of a first fixed charge all of its rights in respect of any account it has with any person other than the accounts referred to in paragraph (a) above, any amount standing to the credit of any such account and the debt represented by it.

#### 3.6 **Book debts etc.**

The Chargor charges by way of a first fixed charge:

- (a) all of its Income, book and other debts;
- (b) all other moneys due and owing to it; and
- (c) the benefit of all rights in relation to any item under paragraphs (a) and (b) above.

#### 3.7 **Insurances**

- (a) The Chargor assigns absolutely, subject to a proviso for re-assignment on redemption, all of its rights under any contract or policy of insurance taken out by it or on its behalf or in which it has an interest as loss payee or otherwise (together, the "**Insurance Rights**").
- (b) To the extent that they have not been effectively assigned under paragraph (a) above, the Chargor charges by way of a first fixed charge all of its Insurance Rights.

#### 3.8 **Other contracts**

- (a) The Chargor:
  - (i) assigns absolutely, subject to a proviso for re-assignment on redemption, all of its rights:

- (A) under each Occupational Lease or other right granting a right to occupy land or premises on its Property;
  - (B) in respect of all Income;
  - (C) under any guarantee of Income;
  - (D) under each Relevant Contract, to the extent not subject an assignment under (A) above; and
  - (E) under any document, agreement or instrument to which it and any nominee or trustee is party in respect of an Investment; and
- (ii) charges by way of a first fixed charge all of its rights under any other document, agreement or instrument to which it is a party except to the extent that it is subject to any fixed security created under any other term of this Clause 3.
- (b) To the extent that they have not been effectively assigned under paragraph (a)(i) above, the Chargor charges by way of a first fixed charge all of its rights listed under paragraph (a)(i) above.

### 3.9 Miscellaneous

The Chargor charges by way of first fixed charge:

- (a) its goodwill;
- (b) the benefit of any Authorisation (statutory or otherwise) held in connection with its use of any Security Asset;
- (c) the right to recover and receive compensation which may be payable to it in respect of any Authorisation referred to in paragraph (b) above;
- (d) its uncalled capital; and
- (e) the benefit of all rights in relation to any item under paragraphs (a) to (d) above.

### 3.10 Floating charge

- (a) The Chargor charges by way of a first floating charge:
  - (i) all its property and assets both present and future not otherwise effectively mortgaged, charged or assigned by way of legal mortgage, fixed charge or assignment under this Clause 3;
  - (ii) all of its property and assets both present and future situated in Scotland or the rights to which are governed by Scots law,

in favour of the Secured Creditor.

- (b) Except as provided below, the Secured Creditor may by notice to the Chargor, to the extent permitted by any applicable law, convert each floating charge created by this Clause 3.10 into a fixed charge as regards any of the Chargor's assets specified in that notice if:
  - (i) an Event of Default is continuing; or
  - (ii) the Secured Creditor considers those assets to be in danger of being seized or sold under any form of distress, attachment, execution, diligence or other legal process or to be otherwise in jeopardy.
- (c) Each floating charge created by this Clause 3.10 may not be converted into a fixed charge solely by reason of:
  - (i) the obtaining of a moratorium; or
  - (ii) anything done with a view to obtaining a moratorium, under section 1A of the Insolvency Act 1986.
- (d) The floating charge created by this Clause 3.10 will (in addition to the circumstances when this may occur under the general law) automatically convert into a fixed charge over all of the Chargor's assets if an administrator is appointed or the Secured Creditor receives notice of an intention to appoint an administrator, save to the extent prohibited by any applicable law.
- (e) Each floating charge created by this Clause 3.10 is a "**qualifying floating charge**" for the purpose of paragraph 14 of Schedule B1 to the Insolvency Act 1986.

### 3.11 Secured Creditor's discretion in relation to Security Assets

Without prejudice to any other rights of the Secured Creditor after the Security has become enforceable and subject to the terms of the Finance Documents to which any Chargor is a party, the Secured Creditor may at any time after any part or parts of the Security have become enforceable:

- (a) enter into, make, execute, sign, deliver and do all such contracts, agreements, deeds, receipts, payments, assignments, assignations, transfers, conveyances, assurances and things and bring, prosecute, enforce, defend and abandon all such actions, suits and proceedings in relation to the Security Asset as it may think expedient;
- (b) exercise or refrain from exercising, in such manner as in its absolute discretion the Secured Creditor shall think fit, all or any of the rights, powers, authorities discretions or remedies of any Chargor under or in relation to the Security Asset or incidental to the ownership thereof and, in particular but without limiting the generality of the foregoing, exercise all rights to vote or to give any consent or notification or make any declaration in relation to such Security Asset. For the

avoidance of doubt, the Secured Creditor shall not be required to have regard to the interests of any Chargor in the exercise or non-exercise of any such rights, powers, authorities, discretions and remedies or to comply with any direction given by any Chargor in relation thereto; and

- (c) demand, sue for and take any advice or institute any proceedings to recover or obtain payment of any amounts which may then be due and payable to any Chargor but which remains unpaid under or in respect of the Security Asset or any part thereof either in its own name or in the name of any Chargor.

#### **4. RESTRICTIONS ON DEALINGS**

##### **4.1 Security**

Except as expressly allowed under the Facility Agreement or the other Finance Documents, the Chargor may not create or permit to subsist any Security on any Security Asset.

##### **4.2 Disposals**

Except as expressly allowed under the Facility Agreement or the other Finance Documents, the Chargor may not enter into a single transaction or a series of transactions (whether related or not and whether voluntary or involuntary) to dispose of all or any part of any Security Asset.

#### **5. LAND**

##### **5.1 Notices to tenants**

The Chargor must:

- (a) serve a notice of assignment, substantially in the form of Part 1 of Schedule 3 (*Forms of Letter for Occupational Tenants*), on each tenant of any Mortgaged Property, such notice to be served:
  - (i) on the date of this Deed for all tenants in place on that date; and
  - (ii) for any new tenant, promptly upon such tenant entering into an Occupational Lease; and
- (b) use reasonable endeavours to ensure that each such tenant acknowledges that notice, substantially in the form of Part 2 of Schedule 3 (*Forms of Letter for Occupational Tenants*).

##### **5.2 Acquisitions**

If the Chargor acquires any freehold, heritable or leasehold property in England and Wales or in Scotland in accordance with the Facility Agreement after the date of this Deed it must:

- (a) notify the Secured Creditor immediately;
- (b) immediately on request by the Secured Creditor and at the cost of the relevant Chargor, execute and deliver to the Secured Creditor:
  - (i) in respect of any property in England and Wales, a legal mortgage over that property; and
  - (ii) in respect of any property in Scotland, a standard security over that property,
 in each case in favour of the Secured Creditor in any form which the Secured Creditor may require; and
- (c)
  - (i) in relation to any property in England and Wales:
    - (A) if the title to that freehold or leasehold property is registered at the Land Registry or required to be so registered, give the Land Registry written notice of this Security; and
    - (B) if applicable, ensure that this Security is correctly noted against that title in the title register at the Land Registry; and
  - (ii) in relation to any property in Scotland, ensure the standard security is registered against the title to that Property in the Land Register of Scotland.

### 5.3 Land Registry

The Chargor consents to a restriction in the following terms being entered into on the Register of Title relating to any Mortgaged Property registered at the Land Registry:

*"No disposition of the registered estate by the proprietor of the registered estate, or by the proprietor of any registered charge, not being a charge registered before the entry of this restriction, is to be registered without a written consent signed by the proprietor for the time being of the charge dated in favour of RS Lender III, S.A R.L. referred to in the charges register or their conveyancer. (Standard Form P)".*

### 5.4 Deposit of title deeds

Except as expressly allowed under the Facility Agreement, the Chargor must immediately:

- (a) deposit with the Secured Creditor all deeds and documents necessary to show good and marketable title to any property referred to in Clause 5.2 (*Acquisitions*) (the "**Title Documents**");
- (b) procure that the Title Documents are held to the order of the Secured Creditor; or

- (c) procure that the Title Documents are held to the order of the Secured Creditor by a firm of solicitors approved by the Secured Creditor for that purpose.

## 6. INVESTMENTS

### 6.1 Deposit

Except as expressly allowed under the Facility Agreement, the Chargor must immediately:

- (a) deposit with the Secured Creditor, or as the Secured Creditor may direct, all certificates and any documents of title or evidence of ownership in relation to its Investments; and
- (b) execute and deliver to the Secured Creditor:
  - (i) duly executed but undated share transfers in respect of its Investments;
  - (ii) signed but undated director resignation letters substantially in the form set out in Schedule 2 (*Form of Resignation Letter*) to this Deed from directors of the companies whose shares form part of the Investments that are subject to security; and
  - (iii) all other share transfers and other documents which may be requested by the Secured Creditor in order to enable the Secured Creditor or its nominees to be registered as the owner of or otherwise obtain a legal title to its Investments, such transfers and other documents to be duly executed but undated, unless otherwise specified by the Secured Creditor.

### 6.2 Calls

- (a) The Chargor must pay all calls or other payments due and payable in respect of any of its Investments to the extent permitted under the Facility Agreement.
- (b) If the Chargor fails to do so, the Secured Creditor may pay the calls or other payments in respect of any of its Investments on behalf of the Chargor. The Chargor must immediately on request reimburse the Secured Creditor for any payment made by the Secured Creditor under this Clause 6.2.

### 6.3 Other obligations in respect of Investments

- (a) The Chargor must promptly send a copy to the Secured Creditor of, and comply with all requests for, information which is within its knowledge and which are made under any law or regulation or any similar provision contained in any articles of association or other constitutional document, or by any listing or other authority, relating to any of its Investments. If it fails to do so, the Secured Creditor may elect to provide such information as it may have on behalf of the Chargor.



- (b) The Chargor must comply with all other conditions and obligations assumed by it in respect of any of its Investments.
- (c) The Secured Creditor is not obliged to:
  - (i) perform any obligation of the Chargor;
  - (ii) make any payment;
  - (iii) make any enquiry as to the nature or sufficiency of any payment received by it or any Chargor; or
  - (iv) present or file any claim or take any other action to collect or enforce the payment of any amount to which it may be entitled under this Deed,
 in respect of any of its Investments.

#### 6.4 Voting rights

- (a) Before this Security becomes enforceable:
  - (i) the voting rights, powers and other rights in respect of its Investments will be exercised:
    - (A) by the Chargor; or
    - (B) if exercisable by the Secured Creditor, in any manner which the Chargor may direct the Secured Creditor in writing,

provided that: (A) it does so for a purpose not inconsistent with the Finance Documents; and (B) the exercise or failure to exercise those rights would not have an adverse effect on the value of the Investments and would not otherwise prejudice the interests of the Secured Creditor, and provided further that the entitlement of the Chargor so to do may be terminated upon and to the extent of any notice by the Secured Creditor to the Chargor evidencing the Secured Creditor's intention henceforth to direct the exercise of such rights for the purposes of preserving the Security; and
  - (ii) all dividends, distributions or other income paid or payable in relation to any of its Investments in accordance with the Facility Agreement must be paid into the Borrower Account.
- (b) The Chargor must indemnify the Secured Creditor against any loss or liability incurred by the Secured Creditor as a consequence of the Secured Creditor acting in respect of any of its Investments as permitted by this Deed on the direction of the Chargor.
- (c) After this Security has become enforceable (but not before), the Secured Creditor may:

- (i) exercise (in the name of the relevant Chargor and without any further consent or authority on the part of any Chargor) any voting rights and any powers or rights which may be exercised by the legal or beneficial owner of any Investment, any person who is the holder of any Investment or otherwise; or
- (ii) require the Chargor to comply with the requirements of such exercise of rights or powers and (at the option of Secured Creditor) transfer those Investments into the name of the Secured Creditor or its Delegate, and, on receipt of any notice to this effect:
  - (A) the Chargor shall comply with any such notification or requirement; and
  - (B) execute and deliver to the Secured Creditor, or to the Receiver or Delegate who made the notification, such forms of proxy, transfers and other documents as that person may require to ensure such compliance.

## 7. ACCOUNTS

### 7.1 General

In this Clause 7 "**Account Bank**" means a person with whom an Account in the name of the Chargor is maintained under the Facility Agreement.

### 7.2 Book debts and receipts

The Chargor must get in and realise its:

- (a) Income and other amounts due from tenants or any other occupiers of the Mortgaged Property; and
- (b) book and other debts and other moneys due and owing to it,

in the ordinary course of its business and direct the proceeds of the getting in and realisation to be paid directly into the Borrower Account (and hold such amounts on trust for the Secured Creditor until such time that they are paid into the Borrower Account).

### 7.3 Notices of charge

The Chargor must:

- (a) promptly following the opening of the Accounts, serve a notice of charge, substantially in the form of Part 1 of Schedule 4 (*Forms of Letter for Account Bank*), on each Account Bank; and

- (b) use reasonable endeavours to ensure that each Account Bank acknowledges the notice, substantially in the form of Part 2 of Schedule 4 (*Forms of Letter for Account Bank*).

## 8. **INSURANCES**

The Chargor must:

- (a) immediately serve a notice of assignment, substantially in the form of Part 1 of Schedule 5 (*Forms of letter for Insurers*), on each counterparty to an Insurance; and
- (b) use reasonable endeavours to ensure that such counterparty acknowledges that notice, substantially in the form of Part 2 of Schedule 5 (*Forms of letter for Insurers*).

## 9. **OTHER CONTRACTS**

The Chargor must, at the request of the Secured Creditor:

- (a) promptly serve a notice of assignment or charge (as applicable), substantially in the form of Part 1 of Schedule 6 (*Forms of Letter for Other Contracts*), on each counterparty to a contract listed in Clause 3.8 (*Other contracts*); and
- (b) use reasonable endeavours to ensure that each such party acknowledges that notice, substantially in the form of Part 2 of Schedule 6 (*Forms of Letter for Other Contracts*).

## 10. **WHEN SECURITY BECOMES ENFORCEABLE**

### 10.1 **Event of Default which is continuing**

This Security will become immediately enforceable if an Event of Default occurs and is continuing.

### 10.2 **Discretion**

After this Security has become enforceable, the Secured Creditor may enforce all or any part of this Security in any manner it sees fit or as instructed in accordance with the Facility Agreement.

### 10.3 **Statutory powers**

The power of sale and other powers conferred by section 101 of the Act, as amended by this Deed, will be immediately exercisable at any time after this Security has become enforceable.

## **11. ENFORCEMENT OF SECURITY**

### **11.1 General**

- (a) For the purposes of all powers implied by statute, the Secured Liabilities are deemed to have become due and payable on the date of this Deed.
- (b) Section 103 of the Act (restricting the power of sale) and section 93 of the Act (restricting the right of consolidation) do not apply to this Security.
- (c) The statutory powers of leasing conferred on the Secured Creditor are extended so as to authorise the Secured Creditor to lease, make agreements for leases, accept surrenders of leases and grant options as the Secured Creditor may think fit and without the need to comply with any provision of section 99 or section 100 of the Act.

### **11.2 No liability as mortgagee in possession**

Neither the Secured Creditor nor any Receiver will be liable, by reason of entering into possession of a Security Asset, to account as mortgagee in possession or for any loss on realisation or for any default or omission for which a mortgagee in possession might be liable.

### **11.3 Privileges**

The Secured Creditor and each Receiver is entitled to all the rights, powers, privileges and immunities conferred by the Act on mortgagees and receivers duly appointed under the Act, except that section 103 of the Act does not apply.

### **11.4 Protection of third parties**

No person (including a purchaser) dealing with the Secured Creditor or a Receiver or its or his/her agents will be concerned to enquire:

- (a) whether the Secured Liabilities have become payable;
- (b) whether any power which the Secured Creditor or a Receiver is purporting to exercise has become exercisable or is being properly exercised;
- (c) whether any money remains due under the Finance Documents; or
- (d) how any money paid to the Secured Creditor or to that Receiver is to be applied.

### **11.5 Redemption of prior mortgages**

At any time after this Security has become enforceable, the Secured Creditor may:

- (i) redeem any prior Security against any Security Asset; and/or
- (ii) procure the transfer of that Security to itself; and/or

- (iii) settle and pass the accounts of the prior mortgagee, chargee or encumbrancer; any accounts so settled and passed will be, in the absence of manifest error, conclusive and binding on the Chargor.
- (b) The Chargor must pay to the Secured Creditor, immediately on demand, the costs and expenses plus any related irrecoverable VAT incurred by the Secured Creditor in connection with any such redemption and/or transfer, including the payment of any principal or interest.

## 11.6 Contingencies

If this Security is enforced at a time when no amount is due under the Finance Documents but at a time when amounts may or will become due, the Secured Creditor (or a Receiver) may pay the proceeds of any recoveries effected by it into a suspense account or other account selected by it.

## 11.7 Financial collateral

- (a) To the extent that the Security Assets constitute "financial collateral" and this Deed and the obligations of the Chargor under this Deed constitute a "security financial collateral arrangement" (in each case, for the purpose of and as defined in the Financial Collateral Arrangements (No. 2) Regulations 2003), the Secured Creditor will have the right after this Security has become enforceable to appropriate all or any part of that financial collateral in or towards the satisfaction of the Secured Liabilities.
- (b) Where any financial collateral is appropriated:
  - (i) if it is listed or traded on a recognised exchange, its value will be taken as being the value at which it could have been sold on the exchange on the date of appropriation; or
  - (ii) in any other case, its value will be such amount as the Secured Creditor reasonably determines having taken into account advice obtained by it from an independent commercial property adviser, investment bank or accountancy firm of national standing selected by it,

and each Finance Party will give credit for the proportion of the value of the financial collateral appropriated to its use.

## 12. RECEIVER

### 12.1 Appointment of Receiver

- (a) Except as provided below, the Secured Creditor may appoint any one or more persons to be a Receiver of all or any part of the Security Assets if:
  - (i) this Security has become enforceable; or
  - (ii) the Chargor so requests to the Secured Creditor at any time.

- (b) Any appointment under paragraph (a) above may be by deed, under seal or in writing under its hand.
- (c) Except as provided below, any restriction imposed by law on the right of a mortgagee to appoint a Receiver (including under section 109(1) of the Act) does not apply to this Deed.
- (d) The Secured Creditor is not entitled to appoint a Receiver solely as a result of the obtaining of a moratorium (or anything done with a view to obtaining a moratorium) under section 1A of the Insolvency Act 1986.
- (e) The Secured Creditor may not appoint an administrative receiver (as defined in section 29(2) of the Insolvency Act 1986) over the Security Assets if the Secured Creditor is prohibited from so doing by section 72A of the Insolvency Act 1986 and no exception to the prohibition on appointing an administrative receiver applies.

#### **12.2 Removal**

The Secured Creditor may by writing under its hand (subject to any requirement for an order of the court in the case of an administrative receiver) remove any Receiver appointed by it and may, whenever it thinks fit, appoint a new Receiver in the place of any Receiver whose appointment may for any reason have terminated.

#### **12.3 Remuneration**

The Secured Creditor may fix the remuneration of any Receiver appointed by it and the maximum rate specified in section 109(6) of the Act will not apply.

#### **12.4 Agent of the Chargor**

- (a) A Receiver will be deemed to be the agent of the Chargor for all purposes and accordingly will be deemed to be in the same position as a Receiver duly appointed by a mortgagee under the Act. The Chargor alone is responsible for any contracts, engagements, acts, omissions, defaults and losses of a Receiver and for any liabilities incurred by a Receiver.
- (b) No Secured Party and/or the Secured Creditor will incur any liability (either to the Chargor or to any other person) by reason of the appointment of a Receiver or for any other reason.

#### **12.5 Relationship with Secured Creditor**

To the fullest extent allowed by law, any right, power or discretion conferred by this Deed (either expressly or impliedly) or by law on a Receiver may after this Security becomes enforceable be exercised by the Secured Creditor in relation to any Security Asset without first appointing a Receiver and notwithstanding the appointment of a Receiver.

## **13. POWERS OF RECEIVER**

### **13.1 General**

- (a) A Receiver has all of the rights, powers and discretions set out below in this Clause 13 in addition to those conferred on it by any law. This includes:
  - (i) in the case of an administrative receiver, all the rights, powers and discretions conferred on an administrative receiver under the Insolvency Act 1986; and
  - (ii) otherwise, all the rights, powers and discretions conferred on a receiver (or a receiver and manager) under the Act and the Insolvency Act 1986.
- (b) If there is more than one Receiver holding office at the same time, each Receiver may (unless the document appointing him/her states otherwise) exercise all of the powers conferred on a Receiver under this Deed individually and to the exclusion of any other Receiver.

### **13.2 Possession**

A Receiver may take immediate possession of, get in and realise any Security Asset.

### **13.3 Carry on business**

A Receiver may carry on any business of the Chargor in any manner he/she thinks fit.

### **13.4 Employees**

- (a) A Receiver may appoint and discharge managers, officers, agents, accountants, servants, workmen and others for the purposes of this Deed upon such terms as to remuneration or otherwise as he/she thinks fit.
- (b) A Receiver may discharge any person appointed by the Chargor.

### **13.5 Borrow money**

A Receiver may raise and borrow money either unsecured or on the security of any Security Asset either in priority to this Security or otherwise and generally on any terms and for whatever purpose which he/she thinks fit.

### **13.6 Sale of assets**

- (a) A Receiver may sell, exchange, convert into money and realise any Security Asset by public auction or private contract and generally in any manner and on any terms which he/she thinks fit.
- (b) The consideration for any such transaction may consist of cash or non-cash consideration and any such consideration may be payable in a lump sum or by instalments spread over any period which he/she thinks fit.

- (c) Fixtures, other than landlord's fixtures, may be severed and sold separately from the property containing them without the consent of the Chargor.

### **13.7 Leases**

A Receiver may let any Security Asset for any term and at any rent (with or without a premium) which he/she thinks fit and may accept a surrender of any lease or tenancy of any Security Asset on any terms which he/she thinks fit (including the payment of money to a lessee or tenant on a surrender).

### **13.8 Compromise**

A Receiver may settle, adjust, refer to arbitration, compromise and arrange any claim, account, dispute, question or demand with or by any person who is or claims to be a creditor of the Chargor or relating in any way to any Security Asset.

### **13.9 Legal actions**

A Receiver may bring, prosecute, enforce, defend and abandon any action, suit or proceedings in relation to any Security Asset which he/she thinks fit.

### **13.10 Receipts**

A Receiver may give a valid receipt for any moneys and execute any assurance or thing which may be proper or desirable for realising any Security Asset.

### **13.11 Subsidiaries**

A Receiver may form a Subsidiary of the Chargor and transfer to that Subsidiary any Security Asset.

### **13.12 Delegation**

A Receiver may delegate his/her powers in accordance with this Deed.

### **13.13 Lending**

A Receiver may lend money or advance credit to any person.

### **13.14 Protection of assets**

A Receiver may:

- (a) effect any repair or insurance and do any other act which the Chargor might do in the ordinary conduct of its business to protect or improve any Security Asset;
- (b) commence and/or complete any building operation; and
- (c) apply for and maintain any planning permission, building regulation approval or any other Authorisation,



in each case as he/she thinks fit.

### **13.15 Other powers**

A Receiver may:

- (a) do all other acts and things which he/she may consider necessary or desirable for realising any Security Asset or incidental or conducive to any of the rights, powers or discretions conferred on a Receiver under or by virtue of this Deed or law;
- (b) exercise in relation to any Security Asset all the powers, authorities and things which he/she would be capable of exercising if he/she were the absolute beneficial owner of that Security Asset; and
- (c) use the name of the Chargor for any of the above purposes.

### **14. APPLICATION OF PROCEEDS**

All amounts from time to time received or recovered by the Secured Creditor or any Receiver pursuant to the terms of this Deed or in connection with the realisation or enforcement of all or part of this Security will be held by the Secured Creditor and applied in accordance with the Facility Agreement. This Clause 14:

- (a) is subject to the payment of any claims having priority over this Security; and
- (b) does not prejudice the right of any Secured Party to recover any shortfall from the Chargor.

### **15. EXPENSES AND INDEMNITY**

The Chargor must:

- (a) immediately on demand pay to each Secured Party the amount of all costs and expenses (including legal fees) and any irrecoverable VAT thereon incurred by that Secured Party in connection with this Deed including any arising from any actual or alleged breach by any person of any law or regulation; and
- (b) keep each Secured Party indemnified against any failure or delay in paying those costs or expenses.

### **16. DELEGATION**

#### **16.1 Power of Attorney**

The Secured Creditor or any Receiver may, at any time, delegate by power of attorney or otherwise to any person for any period all or any right, power, authority or discretion exercisable by it under this Deed.

## 16.2 Terms

Any such delegation may be made upon any terms and conditions (including the power to sub-delegate) and subject to any restrictions that the Secured Creditor or that Receiver (as the case may be) may, in its discretion, think fit in the interests of the Secured Parties.

## 16.3 Liability

Neither the Secured Creditor nor any Receiver shall be bound to supervise, or be in any way responsible for any damages, costs or losses incurred by reason of any misconduct, omission or default on the part of, any such delegate or sub-delegate.

## 17. FURTHER ASSURANCES

- (a) The Chargor must promptly, at its own expense, take whatever action the Secured Creditor or a Receiver may reasonably require for:
  - (i) creating, perfecting or protecting any security over any Security Asset; or
  - (ii) facilitating the realisation of any Security Asset, or the exercise of any right, power or discretion exercisable, by the Secured Creditor or any Receiver or any of their respective delegates or sub-delegates in respect of any Security Asset.
- (b) The action that may be required under paragraph (a) above includes:
  - (i) the execution of any mortgage, charge, transfer, conveyance, assignment or assurance of any asset, whether to the Secured Creditor or to its nominees; or
  - (ii) the giving of any notice, order or direction and the making of any filing or registration,

which, in any such case, the Secured Creditor reasonably considers necessary or desirable.

## 18. POWER OF ATTORNEY

### 18.1 Power of attorney

The Chargor, by way of security, irrevocably and severally appoints the Secured Creditor, each Receiver and any of their respective delegates or sub-delegates to be its attorney with the full power and authority of the Chargor to execute, deliver and perfect all deeds, instruments and other documents in its name and otherwise on its behalf and to do or cause to be done all acts and things, in each case which may be required or which any attorney may in its absolute discretion deem necessary for carrying out any obligation of the Chargor under or pursuant to this Deed or generally for enabling the Secured Creditor or any Receiver to exercise the respective powers conferred on them

under this Deed or by law. The Chargor ratifies and confirms whatever any attorney lawfully does or purports to do under its appointment under this Clause 18.

## 18.2 Exercise of power

The appointment effected under this Clause 18 shall take effect immediately (in the case of a Receiver, upon his/her appointment) but the powers conferred shall only become exercisable upon:

- (a) the occurrence of an Event of Default which is continuing (which upon the appointment of a Receiver shall be deemed to be the case); or
- (b) if the Chargor does not fulfil any of its obligations under Clause 17 (*Further Assurances*) within 3 Business Days of notice from the Secured Creditor or Receiver to do so.

## 19. MISCELLANEOUS

### 19.1 Continuing Security

This Security is a continuing security and will extend to the ultimate balance of the Secured Liabilities regardless of any intermediate payment or discharge in whole or in part.

### 19.2 New Accounts

- (a) If any subsequent charge or other interest affects any Security Asset, a Secured Party may open a new account with the Chargor.
- (b) If that Secured Party does not open a new account, it will nevertheless be treated as if it had done so at the time when it received or was deemed to have received notice of that charge or other interest.
- (c) As from that time all payments made to that Secured Party will be credited or be treated as having been credited to the new account and will not operate to reduce any Secured Liability.

### 19.3 Time deposits

Without prejudice to any right of set-off any Secured Party may have under any other Finance Document or otherwise, if any time deposit matures on any account the Chargor has with any Secured Party within the Security Period when:

- (a) this Security has become enforceable; and
- (b) no Secured Liability is due and payable,

that time deposit will automatically be renewed for any further maturity which that Secured Party considers appropriate.

20. **RELEASE**

At the end of the Security Period, the Finance Parties must, at the request and reasonable cost of the Chargor, take whatever action is necessary to release its Security Assets from this Security.

21. **COUNTERPARTS**

Each Finance Document may be executed in any number of counterparts, and this has the same effect as if the signatures on the counterparts were on a single copy of the Finance Document.

22. **GOVERNING LAW**

This Deed and any non-contractual obligations arising out of or in connection with it are governed by English law.

23. **ENFORCEMENT**

23.1 **Jurisdiction**

- (a) Save as explicitly provided for in any Finance Document to the contrary, the courts of England have exclusive jurisdiction to settle any dispute arising out of or in connection with the Finance Document (including a dispute relating to the existence, validity or termination of that Finance Document or any non-contractual obligation arising out of or in connection with that Finance Document) (a "**Dispute**").
- (b) The Parties agree that the courts of England are the most appropriate and convenient courts to settle Disputes and accordingly no Party will argue to the contrary.
- (c) This Clause 23 is for the benefit of the Finance Parties only. As a result, the Finance Parties shall not be prevented from taking proceedings relating to a Dispute in any other courts with jurisdiction. To the extent allowed by law, the Finance Parties may take concurrent proceedings in any number of jurisdictions.
