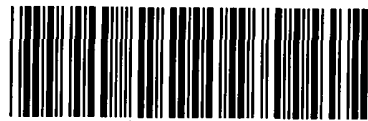

PRINCIPAL ACTIVITIES AND REVIEW OF THE BUSINESS

On 17 December 2016 the company changed its name from The London Stone Centre Limited to HCA Carenow Limited.

The company transitioned from UK GAAP to FRS 102 (The Financial Reporting Standard applicable in the UK and Republic of Ireland) as at 1 January 2015. Following rigorous analysis by management no variances in GAAP were identified which impact the financial statements.

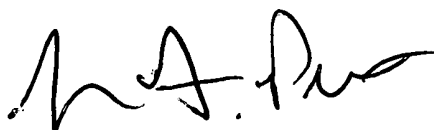
