Removal of Atkinsons as Auditors to MyHome International PLC

I have received the Notice of your proposal to remove me as Auditor at the Company's A G M on 23rd April 2007 Under section 388 (4) Companies Act 1985, I hereby request that you read out at the meeting my Representations contained with this letter Please also advise me of the time of the Meeting as I wish to exercise my rights to be heard orally (Notice of A G M time and location not received until 19th April 2007)

REPRESENTATIONS

- 1 I am a fellow of the Institute of Chartered Accountants in England and Wales
- 2 On 6th December 2006, the directors confirmed their proposal for our re-appointment in accordance with section 385 Companies Act 1985
- 3 I had received no explanation from the company as to why I am being removed from office (a letter dated 18th April 2007 was received today)
- 4 Pressure put up on me to sign the Auditors Report
(The attached emails should also be read out at the A G M)

When Martin Ward and Jonathan Jenkins came to my Hove Office on 1st December 2006, they placed the MyHome cheque book on my desk and made it quite clear that they were ready to pay for the Audit Fees if I would sign off the Audit There then followed a barrage of requests to accept the Australian Contract or to control the scope of my audit in establishing its validity Jonathan Jenkins in his email to me of 3rd December timed 13 30, stated that I was not allowed to make contact with the Australian franchisee Frustration and pressure (including Arif's and Simon's emails) from all sides continued until the morning of 6th December 2006, when Russell agreed to exclude the Australian Contract valued at £399,000 This represented 55% of the original stated profits

- 5 Management letter (Summary) In one of the longest summaries which I have ever written, I covered the considerable problems encountered during the Audit
- 6 Fees amounting to £9,635 remain outstanding since 12th January 2007
