- (c) confirm that it is not intended as at the date of this statement to commence the winding up of the Company within the next 12 months.



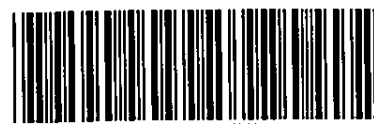
