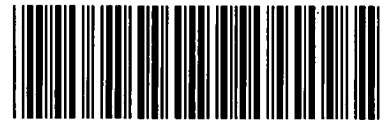




**Accountants' Report to the Board of Directors
