AND pursuant to the above mentioned Act the said Tenon Limited is thereupon to be deemed to have continued in existence as if its name had not been struck off

AND IT IS ORDERED that the Registrar of Companies do advertise notice of this Order in her official name in the "London Gazette"

AND IT IS ORDERED that the Claimant the said Annie Turner do pay to the Registrar of Companies her costs of the said Application in the agreed sum of £300.00
