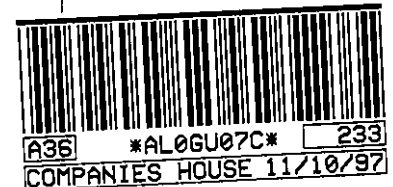



Notes.

1.
