

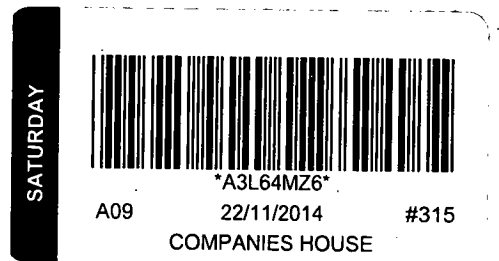

The directors are responsible for preparing the financial statements in accordance with applicable law and regulations.





1 ACCOUNTING POLICIES**1.1 Basis of preparation of accounts**
