Strategic report

The Directors present this strategic report and the financial statements for Preferred Holdings Limited for the year ended 30 November 2014.

Business review

The Company has reported a loss after tax of £29,000 (2013: nil).

On 2 April 2008 Preferred Mortgages Limited announced a suspension of its mortgage lending activities.

On 29 August 2008 the Company resolved to increase the issued share capital to £25,004,954 by the creation of 250,000,000 10p ordinary shares. The additional shares were fully allotted, issued and paid up by Resetfan Limited. The Company used the additional capital to invest in further £25,000,000 £1 ordinary shares in Preferred Group Limited.

The Directors believe the Company's activities will remain unchanged for the foreseeable future.

The Company received no dividend from Preferred Group Limited (2013:£nil).

Principal risks and uncertainties

Financial instrument risks

The financial instruments held by the Company comprise borrowings, investments and receivables that arise directly from its operations.

It is, and has been throughout the year under review, the Company's policy that no trading in financial instruments shall be undertaken.

The main risks arising from the Company's financial instruments are credit risk and liquidity risk. The Directors review and agree policies for managing each of these risks and they are summarised below.

Liquidity risk

Liquidity risk is the risk that investment income receivable by the Company will not arise on a timely manner to meet the Company's obligations as they fall due. The ongoing liquidity risk is closely monitored by the Directors.

The Director of Preferred Mortgages Limited has confirmed that he has no active intention to demand payment of the debt as of 28th August 2015 however no assurance can be given that this intention will not change and all legal rights are retained by Preferred Mortgage Limited. Preferred Mortgages Limited has agreed to provide support for the ongoing running costs of the Company as would be required to enable the Company to meet its future obligations as they fall due for at least the next 12 months and the foreseeable future.

Credit risk

Credit risk is the risk that intercompany debtors will not be able to meet their obligations as they fall due. The ongoing credit risk of these obligations is monitored by the Directors.

Directors' Report

The Directors present this report and financial statements for Preferred Holdings Limited for the year ended 30 November 2014.

Principal activities

The principal activity of the Company is that of a holding company and the Company currently holds the entire share capital of Preferred Group Limited. The principal activity of the Company's group is the provision of loans secured on properties in the United Kingdom.

Results and dividend

The results for the year are shown in the profit and loss account on page 8.

The Directors do not recommend the payment of a dividend for the year (2013:£nil).

Future developments

Following the bankruptcy of the Company's ultimate parent Lehman Brothers Holdings Inc, it continues to be the Directors's intention to ensure an orderly wind down of the Company's assets and operations.

Going concern

The Company's business activities, together with the factors likely to affect its future development, performance and position are set out in the Business Review section of the Strategic Report and the Future Developments section of this report. In addition, the Company's financial risk management policies and objectives are set out in the Principal Risks and uncertainties section of the Strategic Report.

On 15 September 2008, the ultimate parent undertaking, Lehman Brothers Holdings Inc., filed for Chapter 11 bankruptcy protection.

On 23 September 2008, an intermediate parent company Mable Commercial Funding Limited (in administration) was placed into administration.

On 23 September 2008, the principal funder of the Resefan Limited Group which the Company forms part of, Storm Funding Limited (in administration), was placed into administration.

On 6 December 2011, the United States Bankruptcy Court for the Southern District of New York confirmed the modified Third Amended Joint Chapter 11 Plan for Lehman Brothers Holdings Inc. and its Affiliated Debtors (the "Plan") and on 6 March 2012, the "Effective Date" (as defined in the Plan) occurred. As a result of the effectiveness of the Plan, Lehman Brothers Holdings Inc. and its Affiliated Debtors have emerged from bankruptcy. Following this, distributions were made and Preferred Mortgages Limited, the main subsidiary undertaking of the Company, received cash payments from its Affiliated Debtors.

Moreover, as at 30 November 2014, the Company is dependent on the support of group undertakings. The Company continues to have amounts owed to group and related undertakings that are payable on demand. These amounts are primarily owed to its subsidiary company, Preferred Mortgages Limited, which in turn is funded from other group undertakings, primarily Storm Funding Limited (in administration). As at the date of sign-off, Preferred Mortgages Limited has sufficient cash to repay its obligations.

The Director of Preferred Mortgages Limited has confirmed that he has no current intention to demand payment of the debt that the Company owes Preferred Mortgages Limited, however no assurance can be given that the intention will not change and all legal rights to repayment are retained by Preferred Mortgages Limited. The Director of Preferred Mortgages Limited has also confirmed that Preferred Mortgages Limited will continue to fund the ongoing operating expenses of the Company in order for the Company to continue on a going concern basis.

Going concern (continued)

Whilst Preferred Mortgages Limited has sufficient cash to repay its obligations to Storm Funding Limited (in administration), the Directors acknowledge that the overall intention of the Resetfan Limited Group, which the Company forms part of, to continue as a going concern is dependent on the decision of the joint administrators of Mable Commercial Funding Limited (in administration) as the parent entity of the Resetfan Limited Group. Nonetheless, having made enquiries with the joint administrators, the Directors believe that the overall strategy and intention to continue operating in order to realise assets and settle liabilities is supported by the joint administrators. However, no assurance can be given that the current intention will not change within the 12 month period from approval of this report and all legal rights are retained by the joint administrators of Mable Commercial Funding Limited (in administration).

Whilst the Directors recognise there is a material uncertainty over whether Preferred Mortgages Limited will demand repayment of the debt, the Directors believe that Preferred Mortgages Limited will continue to provide the above support given that it is in a net solvent asset position and has sufficient resources to fund its operating expenses and those of its dependent subsidiaries and parents. In addition, based on enquiries, with joint administrators of Mable Commercial Funding Limited (in administration), there is a reasonable expectation that there is no intention to put the entities within the Resetfan Group into an insolvency process.

The Directors have concluded that there is a material uncertainty that may cast significant doubt on the Company's ability to continue as a going concern and, therefore, to continue realising its assets and discharging its liabilities in an orderly manner. Nevertheless, for the reasons stated above, the Directors have a reasonable expectation that the Company will be able to continue in operational existence for the foreseeable future and therefore continues to prepare the financial statements on a going concern basis. The financial statements do not include the adjustments that would result if the Company were unable to continue as a going concern.

Disclosure of information to the auditors

So far as the Directors at the date of approving this report is aware, there is no relevant audit information, being information needed by the auditor in connection with preparing its report, of which the auditor is unaware. 

These amounts are primarily owed to Storm Funding Limited (in administration).

The Directors have concluded that there is a material uncertainty that may cast significant doubt on the Company's ability to continue as a going concern and, therefore, to continue realising its assets and discharging its liabilities in an orderly manner. Nevertheless, for the reasons stated above, the Directors have a reasonable expectation that the Company will be able to continue in operational existence for the foreseeable future and therefore continues to prepare the financial statements on a going concern basis. The financial statements do not include the adjustments that would result if the Company were unable to continue as a going concern.

Group financial statements and schedule 5 disclosures

The Company as a parent undertaking is required to prepare group financial statements by section 399 of the Companies Act 2006 and Financial Reporting Standard 2 'Accounting for Subsidiary Undertakings'. The Company has claimed exemption from preparing group financial statements under section 400 of the Companies Act 2006 as it is itself is a subsidiary undertaking and will be included in the group financial statements of Resetfan Limited.

Fixed asset investments

In the Company's financial statements, investments in subsidiary undertakings are stated at cost, less any necessary provision for diminution in value. The carrying value of investments in subsidiaries is reviewed for impairment when events or changes in circumstances indicate that the carrying value may not be recoverable.

Deferred taxation

The charge for taxation is based on the profit for the year and takes into account taxation deferred because of timing differences between the treatment of certain items for taxation and accounting purposes.

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date where transactions or events that result in an obligation to pay more, or a right to pay less tax in the future, have occurred at the balance sheet date.

Deferred tax assets are recognised only to the extent that the Directors consider it is more likely than not that there will be suitable taxable profits from which the reversal of the underlying timing differences can be deducted. Deferred tax is measured on a non-discounted basis at the tax rates that are expected to apply in periods in which timing differences reverse, based on tax rates and laws enacted or substantively enacted at the balance sheet date.

Cash Flow Statement and Related Party Disclosure

The Company has taken advantage of the exemption under FRS 1 (revised), "Cash Flow Statement" and has not produced a Cash Flow Statement, since it is a wholly owned subsidiary and its immediate parent undertaking, Resetfan Limited, prepares consolidated financial statements that are publicly available. The Company is also exempt under the terms of FRS 8, "Related Party Disclosures", from disclosing related party transactions with entities that are part of the Resetfan Limited group.

11. Ultimate parent undertaking

The Company is controlled by its immediate parent undertaking, Resetfan Limited, which is registered and operates in the United Kingdom.

The ultimate parent undertaking of Preferred Holdings Limited is Lehman Brothers Holdings Inc., which is incorporated in the State of Delaware in the United States of America. On 15 September 2008, Lehman Brothers Holdings Inc., filed for Chapter 11 bankruptcy protection.

On 6 December 2011, the United States Bankruptcy Court for the Southern District of New York confirmed the modified Third Amended Joint Chapter 11 Plan for Lehman Brothers Holdings Inc. and its Affiliated Debtors (the "Plan") and on 6 March 2012, the "Effective Date" (as defined in the Plan) occurred. As a result of the effectiveness of the Plan, Lehman Brothers Holdings Inc. and its Affiliated Debtors have emerged from bankruptcy.

The largest and smallest group in which the results of the Company are consolidated is that headed by Resetfan Limited, registered in England and Wales. The financial statements of the Resetfan Limited group will be available from 23rd Floor, 25 Canada Square, London E14 5LQ.
