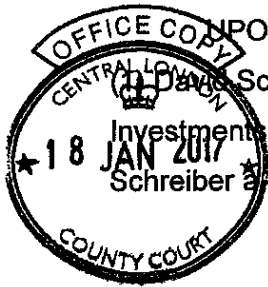

UPON THE APPLICATION by a Claim Form dated the 16 February 2016 of

 Schreiber a co-Claimant and a director of the Company

AND UPON READING the evidence

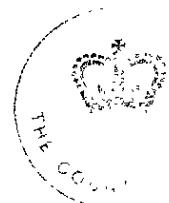


AND IT APPEARING that there is no opposition on behalf of Her Majesty to
 the relief sought by this Claim as appears from the waiver letter from the Treasury
 Solicitor dated the 18 March 2016

AND on leave being given to amend the Claim Form by joining Jacob
 Schreiber as a co-Claimant and re-service being dispensed with

AND upon the Claimants by their Solicitors undertaking to

- (A) take no action regarding the assets of the Company
- (B) immediately upon restoration of the name of the Company to the Register
of Companies present a Petition to the Court for the compulsory winding
up of the Company
- (C) inform the Registrar of Companies of the title and Court reference number
of the said Petition immediately after issue



(D) inform the Registrar of Companies of the outcome of the hearing of the said Petition

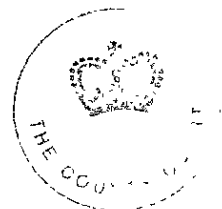
(E) within 21 days of the making of any compulsory winding up Order in respect of the Company deliver an Office Copy of that Order to the Registrar of Companies

AND UPON the Claimants and the Registrar of Companies (the Defendant) both acting by their solicitors both consenting to this Order

IT IS ORDERED THAT:



- (1) the name of the above named Durham Investments Six Limited be restored to the Register of Companies
- (2) if at the date of registration of this Order with the Registrar of Companies the name of the Company is not available the Registrar of Companies shall pursuant to Section 1033(2)(a)(ii) and (b) of the Companies Act 2006 change the name of the Company to 03104360 Limited
- (3) an Office Copy of the Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the Company is thereupon to be deemed to have continued in existence as if its name had not been struck off
- (4) the Registrar of Companies do advertise notice of this Order in his official name in the "London Gazette"
