PRINCIPAL ACTIVITY & REVIEW OF BUSINESS


During the current financial period the company was active as conference services agent and received commission.

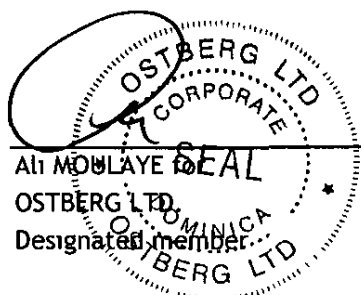


