A member shall not be entitled to attend and vote at general meetings if he fails to comply with a notice served under section 793 of the Companies Act 2006 within a period of 14 days.2. In respect of dividends and other distributions, the right to share pari passu amongst themselves the profits of the Company available for distribution and resolved to be distributed according to the amounts paid up on the ordinary shares, provided that no dividend declared may exceed the amount recommended by the Board. If a member fails to comply with a notice served under section 793 of the Companies Act 2006 within a period of 14 days and his shares represent 0.25 per cent or more of the issued shares of the class in question, any dividend to which he would otherwise be entitled shall be retained (or not issued) without any liability to pay interest when it is finally paid or issued.3. The right, on a winding up of the Company, to share in the balance of the assets available for distribution in proportion to the amount of capital paid up on each ordinary share.4.
