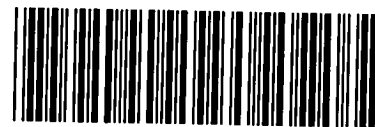


DIRECTOR
