I write further to my appointment as Joint Administrator of the Company, together with Mark Firmin, on 30 September 2013 and the recent report detailing our proposals for the above administration, dated 20 November 2013. I attach Form F2 18, Notice of deemed approval of proposals for filing at Companies House.

Please note that the Joint Administrators did not receive a sufficient level of requests from the Company’s creditors to call a meeting to discuss our proposals, therefore a meeting has not been summoned.

As a result of the above and pursuant to Rule 2.33(5A) of the Insolvency Rules 1986 (as amended), the Joint Administrators’ proposals were deemed to have been accepted on 2 December 2013. This is with the exception of any resolutions in relation to the Joint Administrators’ fees or discharge of their liability, approval for which has been sought from the Company’s secured creditors as per Rule 2.106(5A) of the Insolvency Rules 1986 (as amended) and Paragraph 98(3) of Schedule B1 to the Insolvency Act 1986.
