**SPECIAL RESOLUTION**

THAT:

- (a) the share capital and share premium of the Company as at the date of this resolution be reduced from £55,608.28 to £0.01 (comprised of £573.28 share capital and £55,035.00 share premium) and such reduction shall be effected by cancelling and extinguishing 57,327 ordinary shares of £0.01 each in the capital of the Company;
- (b) the amount of £55,035.00 standing to the credit of the share premium account of the Company at the date of the passing of this resolution be and is hereby cancelled; and
- (c) the reduction of the share capital and the cancellation of the amount standing to the credit of the share premium account of the Company shall be effected by applying the sums arising therefrom to the Company's distributable reserves.

**ORDINARY RESOLUTION**

Pursuant to the Capital Reduction, a distribution of the entire distributable reserves of the Company, and a distribution in specie, to be satisfied by the assignment of any HMRC receivables to the Company to TM Trading, be declared, to be paid or assigned, as applicable on such time and date as the Directors of the Company may determine, to the sole shareholder.
