The directors present their report and the financial statements of the company for the year ended 31 December 2007

### Principal activities

The principal activity of the company during the year was, and will continue to be, that of a holding company. The material investments of the company are shown in note 18.

The company is a wholly-owned subsidiary undertaking of Virgin Media Inc, which changed its name from NTL Incorporated on 6 February 2007 as part of the rebrand to Virgin Media. Virgin is one of the most recognised consumer brands in the world and gives the group a prominent profile in a crowded communications marketplace. The Virgin Media group believes that the strong heritage and reputation of the Virgin brand is a powerful competitive advantage and the Virgin Media group's distinctive approach to advertising, packaging and marketing differentiates it from the competition.

The Virgin Media group is a leading UK entertainment and communications business providing the first "quad-play" offering of television, broadband, fixed line telephone and mobile telephone services in the UK, together with one of the most advanced TV on demand services available in the UK market.

At 31 December 2007, by customer numbers, the Virgin Media group was the UK's largest residential broadband and mobile virtual network provider and the second largest provider in the UK of pay television and fixed line telephone services. The Virgin Media group believes that its advanced, deep fibre access network enables it to offer faster and higher quality broadband services than its digital subscriber line, or DSL, competitors.

Through ntl Telewest Business, the Virgin Media group provides a complete portfolio of voice, data and internet solutions to leading businesses, public sector organisations and service providers in the UK.

Through Virgin Media Television, the Virgin Media group also provides a broad range of programming through its wholly-owned channels, such as Virgin 1, Living and Bravo, through UKTV, its joint ventures with BBC Worldwide, and through the portfolio of retail television channels operated by sit-up tv.

On 8 February 2007, the company changed its name from ntl Investment Holdings Limited to Virgin Media Investment Holdings Limited and the names of certain Virgin Media group companies were changed including

- ntl Communications Limited became Virgin Media Communications Limited
- ntl Cable PLC became Virgin Media Finance PLC
- ntl Group Limited became Virgin Media Limited

The new company names are used throughout the rest of this report and financial statements whether describing events before or after the change of name.

### Future developments

The Virgin Media group's deep fibre access network has enabled it to take a leading position in the roll-out of next generation broadband access technologies in the UK. During 2008 and 2009, the Virgin Media group plans to deploy the next generation of wideband cable broadband technology enabling ultra-fast broadband services of 50Mb and higher. The investment in next generation broadband access technologies is the latest in a series of significant infrastructure investments to ensure that the Virgin Media group remains at the forefront of communication and entertainment services in the UK.



### 1. Accounting policies

#### *Accounting convention*

The financial statements have been prepared under the historical cost convention, modified to include the revaluation of financial instruments, and in accordance with applicable UK accounting standards

#### *Group accounts*

The company has taken advantage of the exemption from preparing group accounts afforded by Section 228 of the Companies Act 1985 because it is a wholly owned subsidiary of another company incorporated in Great Britain which prepares group accounts (see note 17). These financial statements therefore present information about the company as an individual undertaking and not about its group.

#### *Investments*

Investments are recorded at cost, less any provision for impairment. The company assesses at each reporting date whether there is an indication that an investment may be impaired. If any such indication exists, the company makes an estimate of the asset's recoverable amount. Where the carrying amount of an asset exceeds its recoverable amount, the asset is considered impaired and is written down to its recoverable amount. A previously recognised impairment loss is reversed only if there was an event not foreseen in the original impairment calculations, such as a change in use of the assets or a change in economic conditions. The reversal of impairment loss would be to the extent of the lower of the recoverable amount and the carrying amount that would have been determined had no impairment loss been recognised for the asset in prior years.

#### *Cash flow statement*

The company has taken advantage of the exemption under FRS 1 (revised) not to prepare a cash flow statement as it is a subsidiary which is at least 90% controlled by the ultimate parent undertaking (see note 17).

#### *Deferred taxation*

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date where transactions or events have occurred at that date that will result in an obligation to pay more, or a right to pay less or to receive more tax, with the following exceptions:

- provision is made for deferred tax on gains arising from the revaluation (and similar fair value adjustments) of fixed assets, and gains on disposal of fixed assets that have been rolled over into replacement assets, only to the extent that, at the balance sheet date, there is a binding agreement to dispose of the assets concerned. However, no provision is made where, on the basis of all available evidence at the balance sheet date, it is more likely than not that the taxable gain will be rolled over into replacement assets and charged to tax only where the replacement assets are sold, and

- deferred tax assets are recognised only to the extent that the directors consider that it is more likely than not that there will be suitable taxable profits from which the future reversal of the underlying timing differences can be deducted.

Deferred tax is measured on an undiscounted basis at the tax rates that are expected to apply in the periods in which timing differences reverse, based on tax rates and laws enacted or substantively enacted at the balance sheet date.

### 1. Accounting policies *(continued)*

#### *Foreign currencies*

Transactions in foreign currencies are recorded at the rate ruling at the date of the transaction. Monetary assets and liabilities denominated in foreign currencies are translated at the rate of exchange ruling at the balance sheet date. The resulting exchange differences are taken to the Profit and Loss Account.

#### *Derivative financial instruments and hedging*

The company uses derivative financial instruments in the form of interest rate swaps, cross currency swaps and foreign currency forward contracts, to hedge its exposures to foreign exchange and interest rate fluctuations. The Virgin Media group policy is not to undertake any trading activity in financial instruments.

Derivative financial instruments are initially recognised at fair value on the date on which the derivative contract is entered into and are subsequently remeasured at fair value at each period end. Derivatives are carried as assets when the fair value is positive and as liabilities when the fair value is negative.

The fair value of forward currency contracts is calculated by reference to current forward exchange rates for contracts with similar maturity profiles. The fair value of interest rate swap contracts is determined by reference to market values for similar instruments.

For those derivatives designated as hedges and for which hedge accounting is desired, the hedging relationship is documented at its inception. This documentation identifies the hedging instrument, the hedged item or transaction, the rate of the risk being hedged and how effectiveness will be measured throughout its duration. Such hedges are expected at inception to be highly effective.

For the purposes of hedge accounting, hedges are classified as fair value hedges when they hedge the exposure to changes in the fair value of a recognised asset or liability, or cash flow hedges where they hedge exposure to the variability in cash flows that is due to the risk associated with a recognised asset or liability or a forecast transaction. The company discontinues hedge accounting if the hedging instrument expires, is terminated, exercised, no longer meets the criteria for hedge accounting or the company revokes the designation.

#### *Fair value hedges which meet the conditions for hedge accounting*

Any gain or loss from remeasuring the hedging instrument is recognised in the Profit and Loss Account and any gain or loss on the item that is being hedged is adjusted against its carrying amount in the Balance Sheet and is also recognised in the Profit and Loss Account.

#### *Cash flow hedges which meet the conditions for hedge accounting*

The proportion of the gain or loss on the measurement of the hedging instrument that is deemed to be effective is recognised in equity, through the Statement of Total Recognised Gains and Losses, and ineffective portion is recognised in the Profit and Loss Account.

#### *Derivatives that do not qualify for hedge accounting*

Any gains or losses arising from changes in fair value are taken to the Profit and Loss Account.

#### Trade and other debtors

The impairment review of investments concluded that their carrying value was in excess of their recoverable amount. As a result investments have been written down by £351,800,000 (2006 - £nil). The company utilised external professional valuations in order to determine its own valuations of its investments.

Auditor's remuneration disclosed of £8,000 (2006 - £8,000) represents costs attributed to the company by the fellow group undertakings that pay all auditor's remuneration on behalf of the Virgin Media group. The company is exempt from disclosing additional information regarding non-audit services, as the disclosures required under Regulation 4 (1) (b) of Section 390B of the Companies Act 1985, are made in the group accounts of Virgin Media Finance PLC on a consolidated basis.

The UK corporation tax rate will decrease from 30% to 28% from 1 April 2008. This rate change will affect the amount of the future cash tax payments to be made by the Virgin Media group. The deferred tax asset not recognised has been reduced by £29,000 in the current year to reflect this tax rate change.

The bank loans (other than the £300 million Tranche C of the senior credit facility) have the benefit of a full and unconditional senior secured guarantee from Virgin Media Finance PLC as well as first priority pledges of the shares and subsidiaries of substantially all of the operating subsidiaries of the company (see note 18) and of receivables arising as a result of inter company loans to those subsidiaries. The senior secured guarantee of Virgin Media Finance PLC is secured by a first priority pledge of the entire share capital of the company and the receivables under any inter-company loans from Virgin Media Finance PLC to the company. The guarantee of the £300 million Tranche C of the senior credit facility will share in the security of Virgin Media Finance PLC granted to the senior credit facility, but will receive proceeds only after other tranches and will not benefit from guarantees or other security granted by other members of the group.

The annual rates of interest payable on the bank loans are the sum of the London Intra-bank Offer Rate (LIBOR), US LIBOR or European Intra-bank Offer Rate (EURIBOR), as applicable, plus the applicable interest margin and the applicable cost of complying with any reserve requirement. The margins charged range from 1.25% to 2.75% (2006 - 1.25% to 2.75%).

### 11. Derivative instruments and hedging activities

The company's principal financial liabilities, other than derivatives comprise bank loans (senior credit facility) and loans owed to Virgin Media Finance PLC on terms matching the issued Senior Notes with third parties. The company has various financial assets such as cash and short term deposits together with loans to subsidiary companies generally on terms matching the related third party funding.

The company's operations expose it to a variety of financial risks that include interest rate risk, credit risk, liquidity and foreign currency risk.

The company's policies in relation to managing these risks are predominantly driven by the terms of the senior credit facility, which requires the use of hedging instruments to ensure that the group has limited exposure to fluctuations in interest rates and foreign exchange movements. As a result the group enters into derivative transactions, primarily interest rate swaps, cross-currency swaps and forward currency contracts.

It is, and was throughout 2007 and 2006, the company's policy that no trading in derivatives for speculative purposes shall be undertaken.

The Virgin Media group's management reviews and agrees policies for managing each of these risks which are summarised below.

#### *Interest rate risk*

The company is subject to interest rate risk because it has substantial indebtedness at variable rates of interest. At 31 December 2007, before taking into account hedging instruments, interest is determined on a variable basis on £4.8 billion or 81% of indebtedness for the Virgin Media group, of which the company owes £2.2 billion. The Virgin Media group is required by the terms of the senior credit facility to ensure that interest is payable at fixed rates on not less than 66.6% of its financial liabilities, when taking into account the effect of hedging instruments, for at least 3 years from the date of the merger with Telewest on 3 March 2006. The group was in compliance with this requirement throughout the year ended 31 December 2007.

#### *Credit risk*

Credit risk is the risk that one party to a financial instrument will cause a financial loss for that other party by failing to discharge an obligation

The company only has inter-company debt with other wholly-owned fellow group companies. The group's inter-company funding arrangements are managed centrally. Recoverability of inter-company receivables is assessed annually. The provision for non-recoverability may increase or decrease as a result of that review.

Cash deposits and similar financial instruments give rise to credit risk, which represents the loss that would be recognised if a counterparty failed to perform as contracted. Management seeks to reduce this risk by monitoring on a continuing basis the long-term credit rating of deposit counterparties and placing limits on exposure to any counterparty.

#### *Liquidity risk*

The company's financial instruments mainly comprise bank loans, and payable and receivable inter-company debt. The main purpose of these financial instruments is to raise finance for the company's operations, and then to centralise funding within the Virgin Media group. Capital management policies are operated at a group level by management of Virgin Media Inc. The agreements that govern the group's indebtedness set out financial maintenance tests and restrictive covenants, and it is the policy of the Virgin Media group to maintain adequate headroom against these tests and covenants.

As of 31 December 2007, the group had £5,896.6 million of external debt outstanding compared to £6,059.4 million as of 31 December 2006 and cash and cash equivalents of £310.0 million compared to £384.1 million at 31 December 2006. The decrease in debt since the previous year is primarily attributable to a mandatory prepayment of the senior credit facility of £73.6 million in May 2007 as a result of additional cash generated in 2006, a voluntary prepayment of £200 million in December 2007 from existing cash balances and exchange rate movements in debt denominated in currencies other than pound sterling.

The Virgin Media group's business is capital intensive and the group is highly leveraged. The group has significant cash requirements for operating costs, capital expenditure, interest expense and debt repayment requirements. The level of the group's capital and operating expenditures are affected by significant amounts of capital required to connect customers to the network, expand and upgrade the network, offer new services and integrate billing systems and customer databases.

#### *Currency risk*

The Virgin Media group is also subject to foreign currency exchange risks, because substantially all of its revenues and operating expenses are paid in pounds sterling, but interest and principal obligations with respect to a portion of its indebtedness are paid in US Dollars and Euros. The extent that the pound declines in value against the US Dollar and the Euro, the effective cost of servicing US Dollar and Euro denominated debt will be higher. Changes in the exchange rate result in foreign currency gains or losses. As of 31 December 2007, £809.7 million, or 14% of external indebtedness, was denominated in US Dollars and £522.1 million, or 9% of external indebtedness, was denominated in Euros. The group is required to use currency rate hedging in respect of 100% of the aggregate senior facility and Senior Notes which are denominated in US Dollars and Euros for a period of not less than 3 years from the date of the merger with Telewest on 3 March 2006. When taking into consideration forward currency contracts, all external debt is hedged against foreign currency exchange rate risk.

#### *Fair values of financial assets and liabilities*

The company has obligations in a combination of U S Dollars, Euros and Sterling at fixed and variable rates of interest. As a result, the company is exposed to variability in its cash flows and earnings resulting from changes in foreign currency exchange rates and interest rates. The company has entered into a number of derivative instruments on behalf of itself and other group companies with a number of counter-parties to manage these exposures, to the extent required by the terms of the Virgin Media group's senior credit facility.

#### *Interest Rate Swaps*

The company has entered into interest rate swap agreements to manage the exposure to variability in future cash flows on the interest payments associated with £2,450 million (2006 - £2,150 million) of the Virgin Media group's outstanding senior credit facility, which accrue at variable rates based on LIBOR. The interest rate swaps allow the company to receive interest based on three and six month LIBOR in exchange for payments of interest at fixed rates of between 4.68% and 5.38% (2006 - 5.09% and 5.30%).

#### *Cross-Currency Interest Rate Swaps*

The company has entered into cross-currency interest rate swaps with principal amounts of \$1,625 million (2006 - \$1,625 million) and €725 million (2006 - €725 million).

The company hedges the pound sterling value of interest payments on the Virgin Media group's U S Dollar denominated 8.75% senior notes due 2014, its U S Dollar denominated 9.125% senior notes due 2016 and its Euro denominated 9.75% senior notes due 2014. Under these cross-currency agreements the company receives interest in U S Dollars at a fixed rate of 8.75% on the 2014 senior notes and 9.125% for the 2016 senior notes. In addition, the company receives Euros at a fixed rate of 8.75% for the 2014 senior notes. In exchange the company makes payments of interest in Sterling at fixed rates of 9.42% for the U S Dollar denominated senior notes due 2014, 8.54% for the U S dollar denominated senior notes due 2016 and 10.26% for the Euro denominated senior notes due 2014.

#### *Foreign currency forward contracts*

At the balance sheet date the company had outstanding foreign currency forward rate contracts to purchase \$425 million, maturing in April 2009. These contracts economically hedge changes in the pound sterling value of the U S dollar denominated principal obligation of the 8.75% senior notes due 2014 caused by changes in the U S dollar and pound sterling exchange rates.

The foreign currency forward rate contracts are not accounted for as hedges. As such, the contracts are carried at fair value on the company's Balance Sheet with changes in fair value recognised immediately in the profit and Loss Account. The forward rate contracts do not subject the company to material volatility in its earnings or cash flows because changes in the fair value directionally and partially mitigate the gains or losses on the translation of its U S Dollar denominated debt into its functional currency of Sterling.

### 12. Contingent liabilities

The company, along with fellow group undertakings, is party to a senior secured credit facility with a syndicate of banks under which it has guaranteed the borrowings of certain Virgin Media group companies. At 31 December 2007, the company's maximum contingent liability represented by outstanding borrowings under this facility amounted to approximately £3,713 million (2006 - £3,309 million). Borrowings under the facility are secured against the assets of certain members of the group including those of the company.

The company has joint and several liabilities under a group VAT registration.

### 13. Related party transactions

The company has taken advantage of the exemption under FRS 8 not to disclose transactions with group undertakings as it is a subsidiary undertaking which is at least 90% controlled by the ultimate parent undertaking.

As shown in the note 6 (taxation) and note 8 (debtors), losses surrendered by way of Consortium Relief to joint ventures of the Virgin Media group gave rise to amounts recoverable totalling £4,024,000, of which £2,081,000 was recovered after the end of the year.

**(a) Convertible senior notes issue**

On 16 April 2008, Virgin Media Inc issued \$1.0 billion of 6.5% convertible senior notes and used the net proceeds and cash in hand to repay £504.0 million of Virgin Media group's obligations under the senior credit facility that were originally scheduled to be paid in 2009, 2010 and 2012. **(b) Proposed amendments to senior facilities agreement**

On 13 October 2008 the Virgin Media group announced that it was seeking the consent of its senior lenders to amendments to its senior facilities agreement which would, alongside other changes, roll back repayments, including those owed by the company, to participating lenders to June 2012.

Should the lenders consent to the new provisions the company will pay interest at a margin 1.375% higher than the margin paid on its existing borrowings under Tranche A of the senior facility and 1.50% higher than the margin paid on its existing borrowings under Tranche B of the senior facility.

The repayment profile and rates of interest payable on the company's borrowings under Tranche C of the senior facility will remain unchanged.
