IT IS ORDERED THAT:

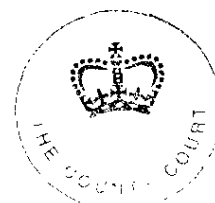


- (1) the name of the above named 01168955 Limited be restored to the Register of Companies
