EACH ORDINARY SHARE AND EACH PREFERENCE SHARE SHALL CARRY ONE VOTE. THE HOLDERS OF PREFERENCE SHARES SHALL NOT BE ENTITLED TO ANY DIVIDEND PROCEEDS. ANY EXIT PROCEEDS SHALL BE DISTRIBUTED AMONGST THE SHAREHOLDERS IN THE MANNER AND ORDER OF PRIORITY SET OUT BELOW: FIRST, IN PAYING TO THE HOLDERS OF THE PREFERENCE SHARES THE SUM OF  $\pounds 1.00$  IN RESPECT OF EACH PREFERENCE SHARE HELD. IF THERE IS A SHORTFALL OF ASSETS ON AN EXIT TO SATISFY THE ENTITLEMENTS OF HOLDERS OF PREFERENCE SHARES IN FULL, THE PROCEEDS SHALL BE DISTRIBUTED TO THE HOLDERS OF THE PREFERENCE SHARES PRO RATA TO THE NUMBER OF PREFERENCE SHARES HELD BY EACH OF THEM ON THE DATE OF THE EXIT; AND SECOND, IN PAYING THE HOLDERS OF THE ORDINARY SHARES ANY REMAINING EXIT PROCEEDS DIVIDED BETWEEN THEM PRO RATA TO THE NUMBER OF SHARES HELD BY EACH OF THEM ON THE DATE OF THE EXIT. ON A RETURN OF ASSETS ON A LIQUIDATION, WINDING-UP, CAPITAL REDUCTION OR OTHER RETURN OF CAPITAL, THE ASSETS OF THE COMPANY REMAINING AFTER PAYMENT OF ITS DEBTS AND LIABILITIES AND OF THE COSTS, CHARGES AND EXPENSES OF SUCH WINDING-UP, SHALL BE DISTRIBUTED IN THE SAME ORDER OF PRIORITY SET OUT ABOVE.**
