- (1) the name of the above named Micom Limited be restored to the Register of Companies


- (2) the Company do continue in compulsory liquidation

- (4) an Office Copy of this Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the Company is thereupon to be deemed to have continued in existence as if its name had not been struck off
- (5) the Registrar of Companies do advertise notice of this Order in his official name in the "London Gazette"
- (6) the hearing fixed for the 22<sup>nd</sup> July 2011 be vacated




