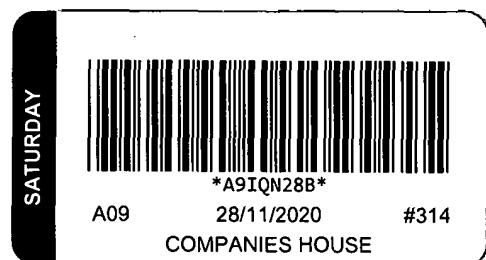


### **Accountants' report to the director of Livewell Today Limited on the preparation of the unaudited statutory accounts for the year ended 31 March 2020**

**1 Statutory information**
