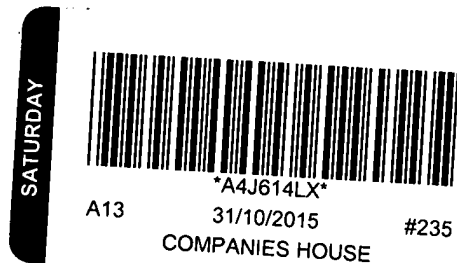

Directors' Report

For the period ended 30 November 2014

The directors present their report and the financial statements for the period ended 30 November 2014.

Directors' responsibilities statement

The directors are responsible for preparing the Directors' report and the financial statements in accordance with applicable law and regulations.

Company law requires the directors to prepare financial statements for each financial year. Under that law the directors have elected to prepare the financial statements in accordance with United Kingdom Generally Accepted Accounting Practice (United Kingdom Accounting Standards and applicable law). Under company law the directors must not approve the financial statements unless they are satisfied that they give a true and fair view of the state of affairs of the company and of the profit or loss of the company for that period. In preparing these financial statements, the directors are required to:

- select suitable accounting policies and then apply them consistently;
- make judgments and accounting estimates that are reasonable and prudent;
- state whether applicable UK Accounting Standards have been followed, subject to any material departures disclosed and explained in the financial statements;
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the company will continue in business.

The directors are responsible for keeping adequate accounting records that are sufficient to show and explain the company's transactions and disclose with reasonable accuracy at any time the financial position of the company and enable them to ensure that the financial statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

Allurian Limited is a non-trading subsidiary within the Easynet Group, the UK's largest independent provider of managed network and hosting services. This independence facilitates its exceptional service and commitment to innovation which in turn enables it to provide the best possible range of services to customers.

Notes to the Financial Statements

For the period ended 30 November 2014

1. Accounting Policies

1.1 Basis of preparation of financial statements

The financial statements have been prepared under the historical cost convention and in accordance with applicable accounting standards.

1.2 Going concern

The Easynet Group, which contains Allurian Limited, is the largest independent provider of managed network and hosting services in the UK. The Group's parent company has committed to supporting Allurian Limited, which benefits from a number of long term service contracts with customers and the financing facilities made available by Easynet FinanceCo Limited.

After making enquiries, the Directors believe that the company, with the support of the Easynet Group, has adequate resources to continue in operational existence for the foreseeable future. The Group as a result will not recall the long-term debt in the immediate future. For this reason the company continues to adopt the going concern basis in preparing the financial statements.

1.3 Current taxation

Current tax is provided at amounts expected to be paid (or recovered) using the tax rates and laws that have been enacted by the balance sheet date.

1.4 Deferred taxation

Full provision is made for deferred tax assets and liabilities arising from all timing differences between the recognition of gains and losses in the financial statements and recognition in the tax computation.

A net deferred tax asset is recognised only if it can be regarded as more likely than not that there will be suitable taxable profits from which the future reversal of the underlying timing differences can be deducted.

Deferred tax assets and liabilities are calculated at the tax rates expected to be effective at the time the timing differences are expected to reverse.

Deferred tax assets and liabilities are not discounted.

1.5 Management of liquid resources

The directors define cash for the purposes of the cash flow statements as cash at bank and in hand.

1.6 Cash flow statement

The company, being a subsidiary undertaking where 90% or more of the voting rights are controlled within the group whose consolidated financial statements are publicly available, is exempt from the requirement to draw up a cash flow statement in accordance with FRS 1.

8. Securities Given

Bank loans and facilities elsewhere in the group are secured by cross-guarantees, debentures and share pledges which include the net assets of Allurian Limited. In particular, this includes the group integration facility of £14m and the secured bank loan of £140m held within the Easynet FinanceCo Limited.

12. Ultimate parent undertaking and controlling party

The ultimate parent undertaking is considered to be MDNX Group Holdings Limited, a Company registered in England and Wales, which indirectly owns 100% of the ordinary share capital of Allurian Limited.

The ultimate controlling parties are the funds managed by Equistone Partners Europe Limited.

The smallest and largest group of undertakings for which group accounts have been drawn up for the period ended 30 November 2014 is the group headed by MDNX Group Holdings Limited, whose financial statements can be obtained from St James House, Oldbury, Bracknell, RG12 8TH.
