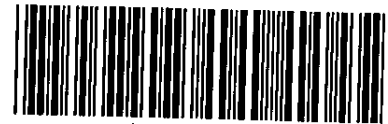



**Asset Realisation and Progression**

The Joint Liquidators confirm that all known assets have been realised.

**Furniture & Equipment**

An amount of £3,000.00 was received from the former Director in relation to the restaurant furniture and equipment.

**Intellectual Property**

An amount of £600.00 was received from the former Director in relation to the rights to the name 'Time & Beef' and the website.

**Cash at Bank**

The sum of £2,245.27 has been received representing the credit balance on the Company's bank account following appointment of Liquidator.

**Bank Interest**

The liquidation funds are held in an interest bearing account and to date the sum of £0.35 has been received in interest.

**Liquidation Costs**

The basis of the Joint Liquidators remuneration was considered and approved on a fixed fee basis, of £10,000 by creditors' on 24 January 2018.

**Pre Appointment Costs**

This firm's fee in relation to assistance provided with the preparation of the director's Statement of Affairs, and placing the Company in liquidation, was fixed at £3,500 plus VAT and disbursements. This fee has been paid in full as detailed within the receipts and payments account.



## Statement re 3<sup>rd</sup> Parties

I can confirm that no payment was made to another party for their assistance in preparing the Statement of Affairs, or in regard to the liquidation generally.

### Liquidators' Remuneration

Numerous activities have been undertaken by ourselves and our staff in dealing with the liquidation. A number of tasks are generic to every liquidation and a summarised list of these activities is attached in the Appendices for your information.

Details of our remuneration are set out below. Time costs accrued to date total £4,797.25, which is calculated at 16.17 hours with an average hourly rate of £296.58 per hour. Of this £4,797.25 was incurred during the period covered by this report. Liquidator's fees of £31.52 have been recovered as detailed in the receipts and payments account.

### Disbursements
