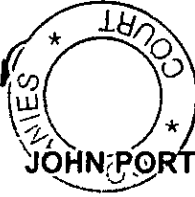

UPON THE APPLICATION by a Claim Form dated the 30 May 2013 of Robert Walton the Claimant and a creditor of the above named John Porter (Newcastle) Limited (hereinafter called "the Company")

AND UPON READING the evidence

AND IT APPEARING that there is no opposition on behalf of Her Majesty to the relief sought by this Claim as appears from the waiver letter from the Treasury Solicitor dated the 20 June 2013

AND the Claimant by his solicitors undertaking to

- (A) inform the Registrar of Companies immediately on the conclusion of litigation issued against the company under claim number 3YL59121 at Northampton County Court referred to in paragraph 4 of the Witness Statement of Richard Martin Scott dated the 24<sup>th</sup> May 2013 or any appeal therefrom or the conclusion of the claim by any other means

- (B) unless the said litigation is completed in the interim, at 6 monthly intervals from the date of this Order to serve on the Registrar of Companies a full and sufficient Witness Statement setting out what steps have been taken to progress the said litigation against the Company

AND UPON the solicitors for the Claimant and for the Registrar of Companies (the Defendant) both consenting to this Order

IT IS ORDERED THAT

- (1) the name of the above named John Porter (Newcastle) Limited be restored to the Register of Companies
- (2) the Company do continue in Creditors' Voluntary Liquidation
- (3) if at the date of registration of this Order with the Registrar of Companies the name of the Company is not available the Registrar of Companies shall pursuant to Section 1033(2)(a)(ii) and (b) of the Companies Act 2006 change the name of the Company to 00261908 Limited
- (4) an Office Copy of the Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the Company is thereupon to be deemed to have continued in existence as if its name had not been struck off

(5) the Registrar of Companies do advertise notice of this Order in his official name in the "London Gazette"

(6) in the event that the Claimant fails to comply with undertaking (C) above the Registrar of Companies be at liberty to commence strike off action in respect of the Company without further notice to the Claimant

(7) the hearing fixed for the 30 August 2013 be vacated
