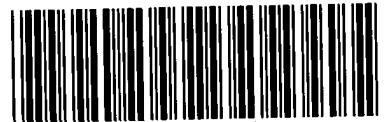


I, the undersigned, being the sole director of the Company for the time being, HEREBY NOTE, CONSIDER AND RESOLVE:
