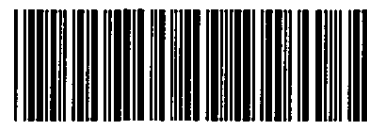

The company has been dormant as defined in section 1169 of the Companies Act 2006 throughout the year and preceding financial period. The company acts as the unremunerated Trustee of the Jaguar Pension Plan, the company did not trade during the year

#### **Statement of directors' responsibilities in respect of the annual report and the financial statements**

The directors are responsible for preparing the Annual Report and the financial statements in accordance with applicable law and regulations

- state whether applicable UK Accounting Standards have been followed, subject to any material departures disclosed and explained in the financial statements, and
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the company will continue in business

The directors are responsible for keeping adequate accounting records that are sufficient to show and explain the company's transactions and disclose with reasonable accuracy at any time the financial position of the company and enable them to ensure that the financial statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the company and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities



**2 Share capital**

The company is limited by guarantee, not having a share capital. The Member of the company undertakes to contribute such amount as may be required (not exceeding £5) to the company's assets if it should be wound up while he is a member or within one year after ceasing to be a member, and of the costs, charges and expenses of winding up, and for the adjustment of rights of the contributories among themselves. At 5 April 2013 the company had one member.

**3 Ultimate parent company**

The company is a wholly owned subsidiary of Jaguar Land Rover Limited throughout the period and at 5 April 2013, which is registered in England and Wales.

The ultimate parent undertaking and controlling party is Tata Motors Limited, a company incorporated in Mumbai, India, which is the parent undertaking of the largest group to consolidate these financial statements. The smallest group to consolidate these financial statements is headed by Jaguar Land Rover Automotive PLC.
