1. **ACCOUNTING POLICIES**

Accounting convention

The company is currently reporting net current liabilities of £15,099 (2015 £23,577). The director has confirmed his intention to provide the necessary financial support for a period of twelve months from the date of signing these financial statements. On the basis of this support the financial statements have been prepared on the going concern basis.

Turnover

Turnover represents net invoiced sales of goods and services. The company is not registered for value added tax.

Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

Fixtures and fittings - 15% on reducing balance
Computer equipment - 25% on cost

Stocks

Stocks are valued at the lower of cost and net realisable value, after making due allowance for obsolete and slow moving items.

Deferred tax

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date.

Hire purchase and leasing commitments

Rentals paid under operating leases are charged to the profit and loss account on a straight line basis over the period of the lease.
