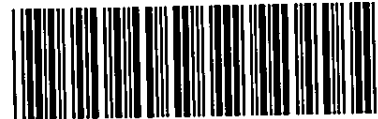

7 Shall submit her accounts to the Claimant at quarterly intervals or when requested to do so by the Claimant upon giving reasonable notice

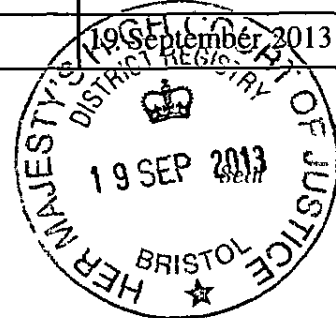
