**UPON THE APPLICATION** of Kevin Gerald Murphy C/O 8 Langside Drive, Ladybridge, Bolton, Lancashire BL3 4US ("**Applicant**" ) dated 26 January 2017

**AND UPON READING** the written evidence of the Applicant and the Respondents each dated 26 January 2017

**IT IS ORDERED THAT -**

- 1 In respect of those Creditors' Voluntary Liquidations ("**CVLs**"), Compulsory Liquidations, Company Voluntary Arrangements ("**CVAs**"), Partnership Voluntary Arrangements ("**PVAs**"), and Administrations listed in Schedules A to E attached to this application ("**Schedules**") which are the subject of proceedings in other District Registries, that those proceedings be transferred to the High Court, Manchester District Registry, solely for the purpose of hearing the application for the Orders sought below
- 2 The High Court shall have jurisdiction over each of the insolvency matters in the attached Schedules which have not yet been issued at Court or have not yet been allocated a Court reference

- 9 The Applicant (insofar as he is removed from office in the respective insolvency proceedings) shall be at liberty to apply to the Secretary of State for his release from his position as liquidator (whether voluntary or compulsory) or as administrator 42 days after the relevant notice referred to in paragraph 8 above has been advertised
- 10 Subject to complying with this Order, the Respondent(s) shall have no obligation to make a further advertisement or provide a further notice to creditors concerning the removal of the Applicant and the appointment of the Respondent(s) (as the case may be)
- 11 Where relevant, the provisions contained in Rules 2 47(3A), 4 49C – CVL(3) and 4.108(3) of the Rules do not apply and the Applicant is not required to file any progress reports on ceasing to act as office-holder pursuant to the proposed Block Transfer Order
- 12 Where relevant Rule 4(5)(b) of the Insolvent Companies (Report on Conduct of Directors) Rules 1996 (SI 1996/1909) shall not apply and the Applicant is not required to submit any reports in respect of any of the CVLs and/or administrations listed in Schedules A and E
- 13 Where relevant, the Respondents shall be obliged to produce and send further progress reports in accordance with the pre-existing reporting requirements of the Applicant
14. Notice of this Order shall be given by the Respondent(s) to each creditor by referring to the terms of the Order in the next report or circular letter that is sent to all creditors
- 15 There be liberty to each creditor to apply to vary or discharge this Order insofar as it relates to the estate of which they are a creditor within 28 days of their being given notice of the Order in accordance with paragraph 14
- 16 Following the Orders made in paragraphs 1 to 11 above, the CVLs, Compulsory Liquidations, CVAs, PVAs and Administrations referred to in the Schedules be transferred back to the respective District Registries, as the case may be
17. Pursuant to Rule 7 10D(4) of the Rules, the costs of this application in relation to paragraphs 3 to 7 shall be apportioned equally and payable as an expense of the

insolvency proceedings to which the application relates save that where such apportioned costs would exceed 10% of the value of the realised assets in such proceedings those costs shall be apportioned equally and payable as an expense of the remaining insolvency proceedings

18 Service of the Application Notice be dispensed with and the time limit for the Secretary of State to respond to the Application Notice be abridged by the Court

19 Such further or other relief as this Honourable Court thinks just
