

**1 Accounting policies**

**Basis of preparation**

The accounts have been prepared under the historical cost convention in accordance with applicable UK accounting standards and on a basis consistent with the previous year

The Company has not traded during the year or the previous year, has incurred no liabilities and, consequently, has made neither profit nor loss. None of the directors received any emoluments in respect of their services to the Company

**2 Investments held as fixed assets**

The Company owns 100% of the issued 'B' ordinary share capital of Thomorg No 8 Limited, a company incorporated in England and Wales and which was dormant for the year ended 31 December 2011. Group accounts are not prepared as the Company is a wholly owned subsidiary of another company incorporated in England and Wales. Within the meaning of the Companies Act 2006 ('CA2006'), Thomson Investments Limited ('TIL') is regarded by the Directors of the Company as being the Company's ultimate parent company and controlling party. Within the meaning of CA2006 Thomson Reuters Corporation ('Thomson Reuters') is the parent undertaking of the only group of undertakings for which group accounts were drawn up and of which the Company was a member for the period ended 31 December 2011. TIL and Thomson Reuters are incorporated under the laws of the Province of Ontario, Canada.
