**Upon the Application of John Arthur Kirkpatrick of Wilkins Kennedy LLP**

**AND upon reading the evidence in support**

**IT IS ORDERED THAT:**

1. Each of the County Court cases listed in Schedule One (attached to this order) be transferred to the High Court of Justice, Chancery Division for the purpose only of making this order.
2. Immediately upon this order taking effect, the County Court cases listed in Schedule One (attached to this order) be transferred back to the County Court.

3. John Arthur Kirkpatrick (**outgoing officeholder**) be removed from office in respect of each of the cases listed in Schedules Two and Three (attached to this order) (**block transfer cases**) from the date of this order.
4. Matthew John Waghorn (**replacement officeholder**) shall be appointed in place of the outgoing officeholder in respect of each of the block transfer cases listed in Schedule Two from the date of this order.
5. Stephen Paul Grant (**replacement officeholder**) shall be appointed in place of the outgoing officeholder in respect of each of the block transfer cases listed in Schedule Three from the date of this order.
6. The creditors in each of the block transfer cases listed in Schedules Two and Three be notified of this order by advertisement published in the London Gazette within 7 days of the date of the order.
7. Any creditor, or, in the case of any members' voluntary liquidation, any member, in respect of any of the companies or persons listed in Schedules Two and Three who has an objection to this order shall have 7 days from the date of the advertisement to apply to court to set aside or vary the terms of this order. Such application shall not affect the transfer of the block transfer cases listed in Schedules Two and Three until further or other order by the court.
8. The replacement officeholders shall give notice to the Secretary of State and the Registrar of Companies in respect of the liquidations listed in Schedules Two and Three of the terms of this order as soon as reasonably practicable.
9. The outgoing officeholder shall file a copy of this order with each of the courts listed in Schedule One.
10. Nothing in this order shall release the outgoing officeholder from any obligation to give and file notices in respect of his removal under this order in respect of the block transfer cases listed in Schedules Two and Three.
11. The outgoing officeholder shall receive his release as Liquidator and/or Trustee in Bankruptcy (as appropriate) 7 days after filing notice of his removal with the Registrar of Companies in the case of any such appointments set out in Schedules Two and Three or the giving of notice to creditors in accordance with this order in any case, save that such release may be subject to further order in the event of an application by any creditor or member under paragraph 7 of this order for the specific case subject to that application.
12. This order shall not affect any officeholders jointly appointed with the outgoing officeholder, save for those officeholders now holding joint office with the replacement officeholders instead of the outgoing officeholder.
13. No order as to costs.
