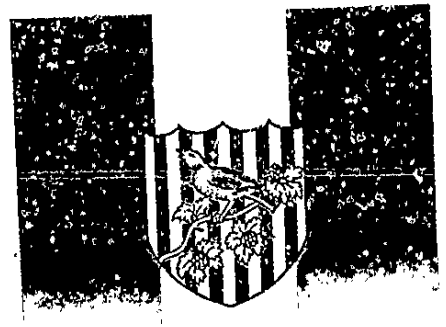

CHAIRMAN'S REPORT

As this is my first report to you as Chairman, I would naturally have wished that it could have been one on a more cheerful note.

We once again suffered an operating trading loss of £191,961 (£344,416 last year) but this was reduced by the net surplus on transfer fees of £66,750 (£629,502 last year).

Your Directors will not be satisfied until we can at least break even in our operating trading account.

Your Board has given top priority during this last year to reducing items of expenditure and this has been carried out very successfully. This particular aspect is now under very strict control. Our Commercial Department is always exploring new avenues of raising and increasing further income and is working very hard to achieve this most difficult task in the present economic climate.

We suffered a considerable financial setback during the year when the professional organisation engaged by our Development Association to promote the Lottery went out of business. The affairs of this organisation are being investigated by the West Midlands Police Commercial Fraud Department at our request.

On a more happy note however, I can tell you that our recently formed Promotions Association started a new lottery under its own administration and under my personal supervision. I am pleased to report that this Lottery is financially successful.

On the playing side, it must be said, however, we had a most dismal and near disastrous year even allowing for an injury list which seemed to grow and grow. As the Season progressed your Board became increasingly concerned with the team's results, general performance and the ever-decreasing attendances, which ultimately resulted in the lowest average gate on record of 14,620. No First Division Football Club can operate successfully on such gates!


We were, however, fortunate to acquire the services of John Giles as Team Manager, and together with Nobby Stiles and Norman Hunter we believe we can face the coming Season with some optimism. Ken McNaught, Tony Morley, Steve Hunt and Tony Grealish are welcomed to the playing staff. We congratulate Steve Hunt on winning his first Cap for England and commiserate once again with Derek Statham who had to withdraw from the England Squad through injury.

We are delighted to welcome back to The Hawthorns Gordon Dimbleby as Secretary/Commercial Manager, and Physiotherapist George Wright.

I wish to place on record the Board's grateful thanks to B.S.R. (Swan) who have supported and sponsored the club for the past three years. We extend a warm welcome to The West Midlands Health Authority who will be our new sponsors for the coming season.

At the forthcoming Annual General Meeting Mr Bert Millic'ip and Mr John Gordon will be retiring from the Board under the new age rule. The Directors wish to place on record their most grateful appreciation to Mr Millic'ip and Mr Gordon for the many years of loyal and devoted service given to the Club. Thank you, gentlemen... we wish you well.

Our thanks are due to all members of staff and supporters alike who saw us through the Season. My personal thanks go to my co-Directors for the loyalty and tremendous support given to me during a most difficult year.

NOTES TO THE ACCOUNTS

31st MAY 1984

1—ACCOUNTING POLICIES

The following accounting policies have been adopted by the Company in the preparation of its Accounts.

- (a) **Basis**
The Accounts have been prepared under the historical cost convention. Comparative amounts have been restated in accordance with the new provisions of the Companies Act 1981.
- (b) **Deferred Taxation**
Deferred taxation is provided at the current rate on the excess of the book value of those fixed assets qualifying for taxation allowances over their written down value for taxation purposes, less unutilised trading losses.
- (c) **Depreciation of Fixed Assets**
Depreciation is calculated on the reducing balance basis, with the exception of Executive Boxes, the Halfords Lane Stand and plant and equipment leased to third parties which are on a straight line basis:

- (d) **Safety of Sports Grounds Act, 1975**
Expenditure arising out of the provisions of the Safety of Sports Grounds Act, 1975 is written off in the year in which it is incurred.
Grants made from the Capital Fund of the Football Grounds Improvement Trust are brought into the Accounts only when received and, in accordance with the agreement between the Football League Limited and the Inland Revenue, are credited to a special account in the Balance Sheet designated "Safety of Sports Grounds Reserve."
- (e) **Stock in Club Shop**
Stocks valued at the lower of first in first out cost or market value.
- (f) **Transfer Fees**
Amounts receivable or payable are respectively included as income or written off as and where appropriate in accordance with the terms of each contract.
- (g) **Rentals receivable under Leasing Agreements**
Rentals are credited to Profit and Loss Account on a time apportionment basis over the period of each agreement.
- (h) **Turnover**
Turnover is stated net of Value Added Tax and comprises gate receipts and other income arising from promotional activities.

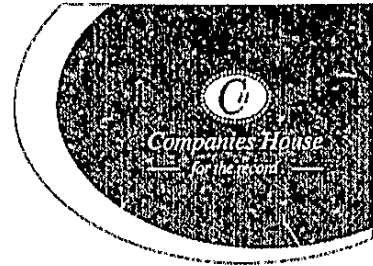
