
- select suitable accounting policies and then apply them consistently,



**1 Accounting policies****1.1 Basis of Preparation**

The accounts are prepared under the historical cost convention as modified by the revaluation of certain assets where applicable, in accordance with the Financial Reporting Standards for Smaller Entities (effective January 2007)

C Taylor, Director of the company is also an employee of Alpha Real Property Investment Advisers LLP (Alpha)  
Alpha also administers the operating partnerships in which the company had an interest during the year. For this service Alpha receives fees as stated below:

- 2.5% p.a. on Residential Development Partnership Capital
- 2.5% p.a. on Commercial Development Partnership Capital
- 2.5% p.a. on Self Storage Partnership Capital
