

NOTES TO THE ABBREVIATED ACCOUNTS

1. Accounting policies

Basis of accounting

The financial statements have been prepared under the historical cost convention, and in accordance with the Financial Reporting Standard for Smaller Entities (effective April 2008)

At the year end the company had net liabilities of £94,249 (2010 - £35,645), which indicates that the company may not be a going concern. However, based on the long term business plans, the director and shareholders are confident that the company will trade profitably in future periods and generate sufficient cash flows to meet its obligations as they fall due for payment.

Cash flow statement

The company has adopted the Financial Reporting Standard For Smaller Entities (effective April 2008) and is consequently exempt from the requirement to include a cash flow statement in the financial statements.

Turnover

The turnover shown in the profit and loss account represents the value of all services provided during the year, at selling price exclusive of Value Added Tax. Sales are recognised at the point at which the company has fulfilled its contractual obligations to the customer.

Tangible fixed assets

Tangible fixed assets are stated at cost less depreciation. Cost represents purchase price together with any incidental costs of acquisition.

Depreciation

Depreciation is calculated so as to write off the cost of an asset, net of anticipated disposal proceeds, over the useful economic life of that asset as follows:

Leasehold Property	-	over 5 years straight line
Plant & Machinery	-	15% reducing balance
Office Equipment	-	15% reducing balance

Operating lease agreements

Rentals applicable to operating leases where substantially all of the benefits and risks of ownership remain with the lessor are charged against profits on a straight line basis over the period of the lease.

Financial instruments

Financial instruments are classified and accounted for as financial assets, financial liabilities or equity instruments, according to the substance of the contractual arrangement.

Financial instruments which are assets are stated at cost less any provision for impairment. Financial liabilities are stated at principal capital amounts outstanding at the period end. Issue costs relating to financial liabilities are deducted from the outstanding balance and are amortised over the period to the due date for repayment of the financial liability.

An equity instrument is any contract that evidences a residual interest in the assets of the company after deducting all of its liabilities. A financial liability is any contractual arrangement for an entity to deliver cash to the holder of the associated financial instrument.

Included in creditors at the balance sheet date was a balance of £55,000 (2010 - £40,000) due to Cellular Solutions Holdings Limited Mr M A Bowers, the director of the company, is both a director and a shareholder in this company

Included in creditors at the balance sheet date was a balance of £10,000 (2010 - £Nil) due to Cellular Solutions (North East) Limited Mr M A Bowers, the director of the company, is both a director and a shareholder in this company

During the year the company paid rent of £33,106 (2010 - £30,347) and service charges of £12,986 (2010 - £Nil) on an arms-length basis to Cellular Solutions Holdings Limited During the year Cellular Solutions Holdings Limited charged the company for rates of £6,684 (2010 - £Nil) and the rental of an Ethernet extension of £1,800 (2010 - £Nil) Included in trade creditors at the balance sheet date was an amount of £20,936 (2010 - £Nil) due to Cellular Solutions Holdings Limited

During the year the company made purchases of £1,198 (2010 - £Nil) on an arms-length basis from IT Professional Services Limited Included in trade creditors at the balance sheet date was a debit balance of £142 (2010 - £Nil) Also included in creditors is a balance of £65,000 (2010 - £50,000) due to IT Professional Services Limited 50% of the shareholders in Workspace Recovery (North East) Limited are also shareholders in the parent company of IT Professional Services Limited
