The Sale Assets

- 1 The Sale Assets of the Business shall comprise the following:
 - (a) the Contracts;
 - (b) the SKF Contract;
 - (c) the Fixtures and Fittings;
 - (d) the General Assets;
 - (e) the Goodwill;
 - (f) the Intellectual Property Rights;
 - (g) the Work in Progress;
 - (h) the Software Licences;
 - (i) the Stock;
 - (j) the Purchase Orders;
 - (k) the Warranty and Service Reserves; and
 - (l) the benefit of the Sales Invoices.
- 2 For the avoidance of doubt the Sale Assets shall include all other assets of Engineering relating exclusively to the Business and not specified in Clause 2 save for the excluded assets referred to in Clause 3.
- 3 There shall be excluded from the Sale Assets:
 - (a) the Cash;
 - (b) the Agency Agreements;
 - (c) the Creditors;
 - (d) the Debts;
 - (e) the statutory books of Engineering;
 - (f) the Excluded Contracts.
- 4 Expressions not previously defined in this Schedule 1 and the other Schedules shall have the following meanings:

"AAA" means an assets purchase agreement dated 20 November 2001 between The Bronx Engineering Company Limited and Bronx Process Engineering Limited (1) and Milevalley Limited (2)

"the Active Contracts" means all of the contracts numbered 1 to 33 and 45 to 54 (inclusive) in Schedule 3 of the AAA.

"the Agency Agreements" means the agency agreements or arrangements (whether these remain in force or have terminated by effluxion of time or otherwise) to which Engineering is a party.

"the Business" the business of the design, engineering, sale and supply, and service of flat products and coil to coil processing equipment including pickling lines, galvanising lines, paint lines, coaters, cut to length lines, slitting lines, packaging lines, press feed lines, as well as, the supply of individual items of equipment comprising such lines as carried on by Engineering at the Transfer Date.

"the Cash" all petty cash and credit bank balances of Engineering in relation to the Business as at the Transfer Date.

"Completion" completion of the sale and purchase of the Sale Assets and the Business in accordance with the provisions of Clause 4 of the AAA.

"the Contracts" all engagements and contracts specified in Schedule 3.

"the Creditors" the trade creditors of Engineering in connection with the Business as at the Transfer Date.

"the Debts" all amounts owing to Engineering in connection with the Business as at the Transfer Date (whether due for payment or not), together with the benefit of all retention of title rights and securities (if any) of Engineering in connection with the same (excluding the Sales Invoices).

"the Excluded Contracts" the Hindalco (140), Norsk Stal (141), Karmax (156), Hydro (164), Severstal (001), ALO (01), Costain (143) and all other contracts relating to the Business other than the Contracts.

"the Fixtures and Fittings" the fixtures and fittings and inventory of which is set out in Schedule 4.

"the General Assets" all intangible assets and choses in action of Engineering not otherwise specifically identified in the AAA exclusively used in the Business including (without limitation) all of Engineering's rights against manufacturers and suppliers (including all rights in connection with such manufacturers' and suppliers' warranties) and any liens in connection with the Business.

"the Goodwill" the goodwill of Engineering in connection with and concerning the Business, together with the exclusive right for the Asset Purchaser to represent itself as carrying on the Business in succession to the Engineering.

"Intellectual Property" patents, trade marks, logos, registered designs, utility models, design right, copyright (including copyright in computer software), inventions, trade secrets and all other intellectual property and rights of a similar or corresponding nature in any part of the world, whether registered or not or capable of registration or not and including all applications and the right to apply for any of the foregoing rights.

"Intellectual Property Rights" all Intellectual Property which is owned or used by the Engineering at the date of the AAA and which is required for the carrying out of the

Business at the date of the AAA and including (but not limited to) those items listed and contained in Schedule 6.

"the Purchase Orders" the purchase orders made by Engineering in connection with and for the benefit of the Business including but not limited to those listed in Schedule 5 relating to any Active Contracts.

"the Products" means the finished goods produced in the course of the carrying on of the Business.

"the Sales Invoices" means any invoices issued by the Engineering in respect of the Business on or after 31 October 2001 payment of which has not been received by the Engineering prior to Completion and set out in Schedule 2.

"the Software Licences" means the AutoCAD and Intellect software and data files connected with such software together with any other software used by Engineering exclusively in the Business.

"the SKF Contract" means a contract dated 30 June 1999 and made between the Engineering (1) and SKF (UK) Limited (2).

"the Stock" means the backup bearings held by Engineering for the benefit of the Business.

"The Transfer Date" means close of business on the date that Completion takes place in accordance with clause 4 of the AAA.

"the Warranty and Service Reserves" means the agreed reserves for the Contracts (excluding the Active Contracts) that will be transferred to the Asset Purchaser at Completion.

"the Work in Progress" the work in progress of the Active Contracts at 31 October 2001 and the stock in trade (excluding the Stock) of including (but not limited to) raw materials, goods and other assets purchased for resale or as components to be incorporated into Products for sale, work in progress, consumable finished goods and packaging or promotional material.
