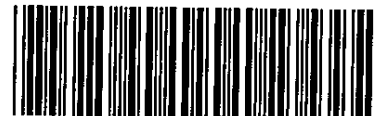



- 3.1 As per the Declaration of Solvency sworn by the company's directors, the company's assets only consist of a trade receivables account amounting to £1 This amount was distributed in specie on 2 April 2014

- 4 1 I have not received any claims from creditors during the course of the liquidation and none are expected

5. Liquidator's remuneration

- 5 1 The Liquidator's remuneration has been determined as a set amount, and has been paid separately by Santander UK plc

6. Liquidator's expenses

- 7 1 As stated above, the company's only asset, being a trade receivables account, was distributed in specie on 2 April 2014


