7 Ultimate parent company and controlling party

8 Contingent Liability

The company has given a guarantee in respect of the ultimate parent company's bank facilities totalling £1,000,000 at 30 September 2009 (2008 £1,000,000). At 30 September 2009 there was a nil sum drawn against this facility (2008 nil).

The guarantee is secured on the Freehold land and buildings owned by the company.
