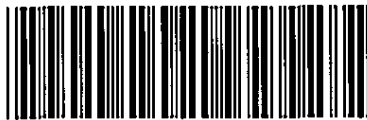

The directors present their report with the financial statements of the company for the year ended 31st March 2008.

PRINCIPAL ACTIVITY

The company's principal activity during the year was tele-sales for clients in the UK, USA and Australia. The company partners with call centres in India and the Far East to deliver its service. Prospect Base's core service is the delivery of qualified sales leads (Appointment Setting) to its customers. These cold calls are first made by sales agents based in India or Far East and then verified/quality checked by sales agents in the UK, before finally delivering them to the customer.

REVIEW OF BUSINESS


The company is entitled to exemption from audit under Section 249A(1) of the Companies Act 1985 for the year ended 31st March 2008.

1. **ACCOUNTING POLICIES**

Accounting convention

The accounts are prepared in accordance with applicable accounting standards under the historical cost convention and on a going concern basis.

As at 31 March 2008, current liabilities of the company exceeded its current assets by £1,123,438. However, the directors of the company consider that the going concern basis is appropriate in view of the assurance of the continual financial support that the company has received from its shareholders.

Financial Reporting Standard Number 1

Exemption has been taken from preparing a cash flow statement on the grounds that the company qualifies as a small company.

Turnover

Turnover represents the invoiced amount of services provided.

The turnover and loss is attributable to the principal activity of the company.
