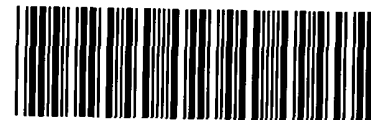



100-1.1 Purpose and Scope. The purpose of this part of the regulations is to establish the standards and procedures for the certification of teachers in the State of New York. This part applies to all public and private schools in the State of New York.

100-1.2 Definitions. For the purposes of this part, the following definitions shall apply: (a) "Candidate" means an individual who is applying for certification as a teacher. (b) "Candidate Number" means the unique identification number assigned to each candidate. (c) "Candidate Information Statement" means the form that candidates must complete and submit as part of their application. (d) "Candidate Interview" means the oral examination conducted by the State Education Department to assess a candidate's knowledge, skills, and abilities. (e) "Candidate Review" means the process by which the State Education Department reviews the results of the candidate interview and determines whether a candidate is eligible for certification. (f) "Candidate Test" means the written examination administered to candidates to assess their knowledge of the subject matter to be taught. (g) "Candidate Test Score" means the score achieved by a candidate on the candidate test. (h) "Candidate Test Results" means the results of the candidate test, including the candidate's score and the number of candidates who achieved a similar score. (i) "Candidate Test Results Report" means the report that the State Education Department prepares and publishes regarding the results of the candidate test. (j) "Candidate Test Results Summary" means the summary of the candidate test results that is published by the State Education Department.
