**1. DIRECTORS' ADVANCES, CREDITS AND GUARANTEES**

At 1 July 2015, the directors' loan account was in a credit balance of £59,823. During the year the director withdrew £359 from the company. As a result, at the end of the year the company owed £59,464 to the directors.
